INTRODUCTION

For a number of years, God has been leading men to seek for a full apostolic gospel standard of experience and doctrine. Some 14 years ago, in answer to prayer, the Lord began to pour out His Spirit in Kansas, then in Texas; and some eight years ago it reached Los Angeles, Cal., and from thence it soon became scattered over the civilized world. It has been so aggressive that almost every city and community in civilization has heard of the Latter Rain outpouring of the Holy Ghost, with many signs following, and not only has civilization been affected to more or less degree, but hundreds of missionaries have consecrated themselves and gone forth until almost every country on the globe has heard the message and also the prophecy which has been predominant in all this great outpouring, which is "Jesus is coming soon" to this old world in the same manner as he left it to set up His millenial kingdom and to reign over the earth in righteousness and peace for a thousand years.

As is true in all great religious awakenings, as evidenced by past history, all kinds of chaotic conditions have been manifested and as this great movement of God has no man nor set of men at the head of it but God to guide and mold it into clean cut Scriptural paths by the Holy Spirit, individualism has been the human order of the day, every man being a law unto himself, and consequently that Scriptural co-operation and fellowship which go far to guarantee the presence and power of God have not been realized in the past in its fullest measure, but as we appropriate the divine order we shall experience the divine presence and power in this respect.

The Pentecostal saints in the United States and Canada especially have seen this great need of co-operation, fellowship and unity, according to the Scriptures, and have felt such a great need of the same in the Home and Foreign Mission work that in different parts of the country brethren have undertaken, we believe in the name of Jesus, to accomplish this end, but seemingly God has a more Scriptural basis and method and a broader field and a greater work than has been accomplished.

Several months ago, men's hearts were calling on God for help to adjust these matters, and open the way by which the Ministerial, Missionary, Publishing and School interests might be advanced to the glory of God. And we believe in answer to our heart's cry, a number of representative workers of the Pentecostal Movement in various parts of the country, called a GENERAL COUNCIL, as was published in WORD AND WITNESS for several months prior to the session, to be held at Hot Springs, Ark., April 2-12, 1914.

PROCEEDINGS OF COUNCIL

DEVOTIONAL SESSION.

The time having arrived, representatives from different parts of the country, including about twenty (20) states, with many workers and saints, met together at Hot Springs, Ark., April 2nd., 1914.

The meetings from the beginning were inspired of the Lord. Love and unity seemed to prevail from the first meeting. The first three days were given especially to devotional services, spiritual messages, reports from the various Local Churches, Foreign Fields, and evangelists. The most blessed spirit of fellowship prevailed with but little exception throughout the gathered host. Men of God, full of faith and of the Holy Ghost were not yet in perfect unity in faith, but retained the unity of the Spirit until the unity of Faith was being much manifested in the meetings.

On Monday, April 6th, the business proper of the Convention began.

BUSINESS SESSION.

Monday, April 6, 10 A. M.

After the opening devotional service, Elder E. N. Bell, of Malvern, Ark., called the Assembly to order for business, and declared the general purpose of the Convention.

On motion Elder E. N. Bell was unanimously elected as Temporary Chairman.

On motion Elder J. R. Flower was unanimously elected as Temporary Secretary.

·On motion it was adopted that the Council should be governed by Parliamentary usage, under the guidance of the Holy Spirit and according to the Word of God.

Conference Committee.

On motion a committee of seven were appointed to act as a Conference Committee, to receive from members of the Council all matters proposed for consideration, and to formulate and present the same to the General Council for approval or disapproval.

On motion Elders Pinson, Arizona; Rogers, Tennessee; Fockler, Wisconsin; Jessup, Mississippi; Edwards, Texas; Gaston, Oklahoma, and Goss, Arkansas, were chosen as the Conference Committee, representing their various states.

On recommendation of the Conference Committee, it was adopted that the Conference Committee be enlarged so as to include a representative from each state and Foreign country represented. The following were added:

J. A. Cullifer, Alabama; Bennett F. Lawrence, Missouri; T. K. Leonard, Ohio; J. Roswell Flower, Indiana; John G. Lake, Pennsylvania and S. Africa; John Goben, Iowa; A. B. Cox, Maryland; John Crouch, Egypt; E. J. Emery, Minnescta; D. K. Morris, Louisiana; W. F. Lankston, Illinois.

Council Roll.

On motion it was adopted that all Missionaries, Ministres, Pastors, Evangelists and Delegates hand in their names to the Conference Committee to form the Council Roll.

On motion it was adopted that all male Ministers and Delegates be eligible to vote in this Assembly, together with those qualified who should arrive later in the session, according to the Secretary's list.

Report of Conference Committee.

The Conference Committee reported the following Preamble and Resolution on Constitution which was presented to the Conference Committee by T. K. Leonard and J. R. Flower, and was unanimously adopted by the Committee, who on motion requested Brother Leonard to present it to the General Council:

PREAMBLE AND RESOLUTION OF CONSTITUTION.

WHEREAS, God, our Heavenly Father, sent His only begotten Son, the Lord Jesus Christ, into the world, Who purchased and redeemed fallen man with His own precious blood, and called out of the world and saved a people, of whom He built and established His Church (Assembly of God. Mat. 16:18), upon the foundation of the Apostles and Prophets, Jesus Christ Himself being the Head and Chief Corner-stone (Eph. 2:20), and organized and baptized it with the Holy Spirit, with its government upon His shoulders (Isaiah 9:6-7), said: "The gates of hell shall not prevail against it" (Matt. 16:18); and

WHEREAS, He gave the Holy Inspired Scriptures, (both old and new covenants, Heb. 8:6-13) as the all-sufficient rule for faith and practice, (2 Tim. 3:16), as follows: "All Scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness: That the man of God may be perfect, thoroughly furnished unto all good works," we therefore shall not add to nor take from it (Rev. 22:18); and

WHEREAS, He commanded that there should be no schism (division, sectarianism) in His Body, the GENERAL ASSEMBLY (Church) of the first born,

which are written in heaven, Heb. 12:23; and

WHEREAS, We recognize ourselves as members of said GENERAL AS-SEMBLY OF GOD, (which is God's organism), and do not believe in identifying ourselves as, or establishing ourselves into, a sect, that is a human organization that legislates or forms laws and articles of faith and has unscriptural jurisdiction over its members and creates unscriptural lines of fellowship and disfellowship and which separates itself from other members of the General Assembly (Church) of the first born, which is contrary to Christ's prayer in St. John 17, and Paul's teaching in Eph. 4:1-16, which we heartily endorse:

THEREFORE, BE IT RESOLVED, FIRST, That we recognize ourselves as a GENERAL COUNCIL of Pentecostal (Spirit Baptized) saints from local Churches of God in Christ, Assemblies of God, and various Apostolic Faith Missions and Churches, and Full Gospel Pentecostal Missions, and Assemblies of like faith in the United States of America, Canada, and Foreign Lands, whose purpose is neither to legislate laws of government, nor usurp authority over said various Assemblies of God, nor deprive them of their Scriptural and local rights and privileges, but to recognize Scriptural methods and order for worship, unity, fellowship, work and business for God, and to disapprove of all unscriptural methods, doctrines and conduct, and approve of all Scriptural truth and conduct, endeavoring to keep the unity of the Spirit in the bonds of peace, until we all come into the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fulness of Christ, and to walk accordingly, as recorded in Eph. 4:17-32, and to consider the five purposes announced in the Convention Call in the February, 1914, issue of "WORD AND WITNESS;" *

RESOLVED, SECOND, That we recognize all the above said Assemblies of various names, and when speaking of them refer to them by the general Scriptural name "Assemblies of God;" and recommend that they all recognize

the chief aim.

SECOND: That we may know how to conserve the work, by all building up and not tearing down, both in home and foreign lands.

THIRD: That we might have a better understanding of the needs of the foreign fields, and regulate our financial affairs to accomplish a greater work in home and foreign lands.

FOURTH: That we may be subject to the laws of State and National government, and be legal in transacting business for God, as taught in Romans 13:1-9, "not slothful in business, but fervent in spirit; serving the Lord; rejoicing in hope; patient in tribulation; continuing instant in prayer; distributing to the necessity of saints; given to hospitality; provide things honest in the sight of all men," etc. (Rom. 12:11-17.) And

FIFTH: As Jesus commanded in the great commission, that the Gospel should be taught, preached and published in all the world before His return, we should consider the Ministerial, School and Publishing interests, to the glory of God, that Jesus may be with us even unto the end of the world. (See Mat. 28:19, 20; Mark 13:10; 16:16.)

^{*}The five purposes announced in Word and Witness were as follows: FIRST: We come together according to Acts 15, that by prayer and study of the Word of God, and guidance of the Holy Spirit, we may get a better understanding of what He would have us teach, and thus do away with many divisions over doctrines and various names under which the Pentecostal people are working and incorporating,—UNITY being the chief aim chief aim. SECOND:

themselves by the same name, that is, "Assembly of God" and adopt it as soon as practicable for the purpose of being more Scriptural and also legal in transacting business, owning property, and executing missionary work in home and foreign lands, and for general convenience, unity and fellowship.

On motion, the above Preamble and Resolution was unanimously adopted amid great demonstration, the whole house rising to their feet and shouting praises to God. "Praise God from whom all blessings flow" was sung. The power of God fell mightily upon the great Assembly. The Council broke up into a great praise meetign. The joy of God filled all hearts, and the multitude were moved to tears, and many wept for joy.

The Conference Committee recommended that the Preamble and Resolutions on Constitution be adopted as the Constitution of the General Council of the Assemblies of God. It was moved and seconded by the Council that the above recommendation be adopted, and after discussion it was unanimously carried.

On motion the Assembly requested that the question of the Church, general and local, her functions and offices from the Bible standard be discussed. The Council adopted the suggestion and requested Brothers M. M. Pinson, John G. Lake, T. K. Leonard, E. N. Bell and A. P. Collins to discuss the question from a Bible standpoint.

Discourses followed.

Brother Bosworth then moved that the Committee be instructed to hold a night session and report to the General Council their best solution of the problem of how to assist most effectively, the Home and Foreign Missionary work. Motion adopted.

Executive Presbytery.

After holding the above special meeting the Conference Committee presented the following resolution for adoption by the Council: "We, your Committee, recommend that the General Council appoint an annual presbytery of twelve men, known as the EXECUTIVE PRESBYTERY, of the General Council of the Assemblies of God, to act in all necessary matters on behalf of this General Council, as a Home and Foreign Missionary and Executive Presbytery, during the ensuing year, or until their successors are appointed. On motion the Resolution was adopted.

On motion nine of the Fresbytery were appointed as follows:

T. K. Leonard, Findlay, Ohio; E. N. Bell, Malvern, Ark; J. R. Flower, Plainfield and Indianapolis, Ind.; H. A. Goss, Hot Springs, Ark; J. W. Welch, Baxter Springs, Kans.; M. M. Pinson, Phoenix, Ariz.; C. B. Fockler, Milwaukee, Wis.; D. C. O. Opperman, Houston, Texas; Jno. C Sinclair, Chicago, Ill.

The other three to be appointed by the Presbytery. (Later the following brethren were appointed as members of the Presbytery: A. P. Collins, Ft. Worth, Texas; R. L. Erickson, Chicago, Ill.; D. W. Kerr, Cleveland, Ohio).

A motion was made and seconded that the resolution be adopted, and after discussion was unanimously carried.

Resolution on Incorporation.

The Conference Committee made the following resolution: "We, your Committee, recommend that, Whereas it is essential to transact business in the United States and Foreign Lands, that we become an Incorporated Body, therefore be it resolved, That the GENERAL COUNCIL recommend and authorize the EXECUTIVE PRESBYTERY to charter this GENERAL COUNCIL of the ASSEMBLIES OF GOD."

On motion and consideration, the above Resolution was unanimously adopted.

Miscellaneous Resolutions.

The Conference Committee recommended that in view of the fact that the work which has been done hitherto in the Interstate Camp Meeting of the Churches of God in Christ, has been committed to the General Council of the Assemblies of God, that the Council publicly recognize itself as the proper place for said business in the future.

On motion the Resolution was adopted.

The Conference Committee recommended that whereas the pressing of the question of eating, or not eating meats, is causing divisions in some of the Assemblies, that the General Council recommend their disapproval of such extreme positions on this question which causes these divisions, and that we recognize the right of each individual conscience in this matter, according to Col. 2:14-17.

The motion was seconded and adopted unanimously.

On motion it was adopted that the General Council recommend to the Assemblies of God everywhere that they meet every Thursday from 10:00 A. M. to 3 P. M. for united prayer, and that those who are situated so that they cannot attend the Assemblies for this purpose observe the time of prayer in their own homes, as far as it is practicable.

The Conference Committee recommended to the General Council that inasmuch as the WORD AND WITNESS is already the property of the GENERAL COUNCIL of the ASSEMBLIES OF GOD, that it be recognized as its Official Organ, with Brother E. N. Bell as Editor, and that the whole matter of Publications be turned over into the hands of the Executive Presbytery.

The recommendation was unanimously adopted.

Publication of Minutes.

On motion it was recommended and adopted that the proceedings of THE GENERAL COUNCIL of the ASSEMBLIES OF GOD, be publised in the May issue of WORD AND WITNESS, and be distributed in large quantities.

The Conference Committee recommended to the GENERAL COUNCIL that, whereas, it is impractical for all the local Assemblies of God in the United States, Canada and Foreign Fields to meet in the GENERAL COUNCIL, and that it would be impossible for the GENERAL COUNCIL to transact the business of the Local Assemblies of God in the various sections of the United States, Canada and the Foreign Fields, that we recommend that the Local Assemblies in the various fields, establish District or State Councils, and that the Presbytery be authorized to appoint Elders or Evangelists to assist the local Assemblies of God in the recognition and establishing of the District or State Councils, that everything may be in harmony in the District Councils with the Constitution of the GENERAL COUNCIL.

On motion the above Resolution was accepted and unanimously carried.

Church Offices and Officers.

The subject of the recognition of the different offices of the Church, which was referred back to the Conference Committee, was revised and presented as follows:

We, the Conference Committee, recognizing that in the Word of God there are set certain offices, which represent the various activities of the body of Christ, recommend that the GENERAL COUNCIL declare themselves in accord with the Word of God on this question, and stand ready to accept and endorse any and all of these various offices as they may appear or develop among us, and so far as they may now be present, stand ready to do so by suitable letters of commendation; and that we also endorse and commend all in whose lives God has already revealed His power in any of these ministries, and as a matter of convenience in their recognition, adopt the Scriptural terms of Elder, Evangelist, Minister, Exhorter and Deacon.

The recommendation was received and discussed, and on motion was unanimously adopted.

Religious Schools and Publications.

A Resolution was presented as follows: Resolved that the GENERAL COUNCIL call attention to the literary school of Brother R. B. Chisolm, near Union, Miss., and recommended the same to those who are in reach of it, and who are seeking literary training for their children in a good religious atmosphere.

We would also call attention to the Gospel School at Findlay, Ohio, under the supervision of Brother T. K. Leonard, and advise those in that section, who are seeking Bible training, to attend the same; and those who desire to take the course of Home Bible study, through the Gospel School Review, by which they finish in one year, a study of the entire Bible, should write T. K. Leonard, Findlay, Ohio.

We further recommend that the students in other localities avail themselves of the courses offered in other Full Gospel or Pentecostal schools within their reach, and avail themselves of all opportunities for the study of the Word. We urge these students to constant prayer (Acts 6:4) and to the study of God's Word, as commended by Paul to Timothy (2 Tim. 2:15), and to preaching the Word everywhere (Acts 8:4) as opportunity affords in connection with their study.

As regards a school for the Southwest, we recommend the matter to be committed to the EXECUTIVE PRESBYTERY, with the authority to act upon the same. Those who have propositions to make are urged to report to the Presbytery.

Also to those who desire a weekly paper, we recommend the Christian Evangel, published at Plainfield, Ind., by Brother J. R. Flower. (Now published at Findlay, Ohio, as the weekly Council organ). We also commend all other safe and reliable Pentecostal papers everywhere.

On motion, after discussion, the above recommendations were unanimously adopted.

Rights and Offices of Women.

The Conference Committee recommended to the GENERAL COUNCIL that whereas the hand of God is mightily upon many women to proclaim and publish the "good tidings of great joy" in a wonderful way, that the GENERAL COUNCIL of the ASSEMBLIES OF GOD submit the following Scriptures for consideration.

- 1. In Christ, that is in the matter of salvation, the lines of sex are blotted out. Gal. 3:28.
- 2. Women are commanded to be in subjection and not to usurp authority over the man. I Tim. 2:11-15.
- 3. They are called to prophesy and preach the Gospel. Acts 2:17. "He that prophesieth speaketh unto men to edification, to exhortation and to comfort." I Cor. 14:3.
 - 4. To be helpers in the Gospel. Rom. 16:3.

Therefore be it resolved, that this Council recommend to the ministry and Assemblies of God, that we recognize their God-given rights to be ordained, not as elders, but as Evangelists and Missionaries, after being duly approved according to the Scriptures.

On motion, the above Resolution was unanimously adopted.

Marriage and Divorces.

The Conference Committee recommended to the GENERAL COUNCIL that:

First, Whereas there are now among Christian people those who became entangled in their marriage relations in their former lives of sin, and who do not now see how these matters can be adjusted, therefore we recommend that these cases be left in the hands of the Lord, and that they walk in the light as God lets it shine on their souls.

Second, Whereas low standards on marriage and divorce are very hurtful to individuals, to the family, and to the cause of Christ, therefore be it recommended that in future we discourage divorce by all lawful means and teaching, and that we shall positively disapprove of divorce for any cause except for fornication or adultery (Matt. 19:9) and (if divorced for any other cause, I Cor. 7:15), that we recommend the remaning single of all divorced Christians, and that they pray God so to keep them in purity and peace. (See I Cor. 7.)

Third, Whereas divorced and remarried persons in the ministry usually cause stumbling, reproach and division, whatever may have been the cause of divorce, therefore we advise and recommend our ministers and Assemblies in the future not to ordain to the full Gospel ministry those who have remarried, and are now living in the state of matrimony, while former companions are living. (Ezeklel 44:22).

After much discussion, the Resolution was adopted.

Miscellaneous Motions.

On motion, E. N. Bell, Temporary Chairman, and J. Roswell Flower, Temporary Secretary, were appointed to act as Chairman and Secretary until the next GENERAL COUNCIL or until their successors are appointed.

On motion the Presbytery was authorized to approve, edit and publish the minutes.

On motion it was recommended that all ministers and laymen be appointed to secure all the subscribers possible for the WORD AND WITNESS.

On motion, the following Resolution was unanimously carried, that in as much as we have come together from various parts of the United States and met in the beautiful City of Hot Springs, and have been so well treated and welcomed, that it be resolved that we extend a vote of thanks and appreciation to the people for their courtesy toward us, and kindness toward this Council.

On motion, the MINUTES as completed and edited by the Presbytery, were adopted and approved.

On motion, the COUNCIL adjourned until the call of the next GENERAL COUNCIL, by the Presbytery.

PROCEEDINGS OF THE GENERAL COUNCIL AT THE STONE CHURCH, CHICAGO, ILL., NOV. 15-29, 1914.

MONDAY, NOV. 16th.

The General Council was called to order by the chairman, E. N. Bell, who called for the enrollment of the delegates.

TUESDAY, NOV. 17th.

The Council was called to order and the names of the delegates present were read. It was then moved and adopted that these, with others yet to be added, should constitute the membership of the General Council.

On motion, A. P. Collins was appointed as chairman of the Council for the coming year.

On motion, J. R. Flower was appointed as secretary and B. F. Lawrence as assistant secretary.

On motion, D. C. O. Opperman was appointed assistant chairman for the coming year.

The Conference Committee.

On motion it was recommended that the Council proceed to the choice of a committee of seven to be appointed by the chair to act as a conference committee to receive and arrange resolutions to be presented to the Council for action.

The chair requested Brother J. W. Welch to act as chairman of the

conference committee, and also requested his help in selecting his co-workers on this committee, and called the Council to prayer that God may help them that all things be done in harmony with meekness and wisdom.

The names of the Conference Committee as selected were J. W. Welch, E. N. Bell, H. A. Goss, B. F. Lawrence, D. W. Kerr, C. B. Fockler and H. G. Rodgers.

Brother W. F. Carothers presented two resolutions to the General Council. On discussion these resolutions were referred to the Conference Committee for revision and later presentation to the General Council.

WEDNESDAY, NOV. 18th.

The General Council was called to order by the chairman and the report of the conference committee was called for.

The Lady Delegates.

The Conference Committee presented the following resolution: "We, your committee, recommend that the following resolution be adopted:

"Resolved, that the sisters visiting this General Council who are mature believers and are in co-operative fellowship with our testimony, be received as advisory members of the Council, and that we recommend to all other deliberative bodies in the movement that they extend like courtesies to sisters of like qualifications in their midst. Rom. 16:1-3; 1 Cor. 11:7-11; Col. 4:3.

On motion, after discussion, the above resolution was adopted.

The Executive Presbytery.

The Conference Committee presented the following resolution:

"We, your committee, recommend that the following resolution be adopted:

"Resolved, That the General Council proceed in the choice of a new presbytery, and that the chairman of the Council appoint a committee of three to nominate the first seven members of the presbytery, who shall in turn nominate the balance of the presbytery, the nominating committees to be open for suggestions from the Council in the selection of the nominees."

On motion, the above resolution was adopted.

On motion, it was agreed that the presbyters be selected by ballot, one at a time.

On motion, it was adopted that if as many as five votes be cast against the selection of any nominee that the name of that one be referred back to the nominating committee, and that those having these objections be requested to appear before the nominating committee and state why they had these objections.

The chair appointed the nominating committee of three as follows: R. L. Erickson, W. F. Carothers, and Jacob Miller.

On motion, D. W. Kerr was requested to read the Scriptures pertaining to the qualifications of an elder or a presbyter. He made some remarks and then read various portions from first and second Timothy and Titus.

The Nominating Committee, after prayerful deliberation, nominated the following brethren as Presbyters: A. P. Collins, D. W. Kerr, J. W. Welch, E. N. Bell, F. F. Bosworth, H. G. Rogers and Andrew L. Fraser.

On motion, the Council received the names of the nominees to be voted

Ballots were cast for each and the entire seven were elected as Presbyters.

THURSDAY, NOV. 19th.

After prayer and the reading of the Word, the Council was called to order by the chairman and the Conference Committee presented the following resolution:

Resolved, That the number of the Executive Presbytery be increased from twelve to sixteen members, that the presbytery be more representative in its character.

On motion, the resolution was unanimously adopted.

The Conference Committee presented the following for adoption: "We, your committee, recommend that the officers of the General Council be recognized as ex officio members of the Executive Presbytery."

On motion, the resolution was unanimously adopted.

The seven presbyters who were recognized as a nominating committee with authority to nominate the remainder of the presbytery, suggested the following names: M. M. Pinson, H. A. Goss, T. K. Leonard, W. F. Carothers.

On motion, the names of each one of these brethren were accepted and they were unanimously elected as members of the executive presbytery.

The Nominating Committee requested that the matter of the selection of the remainder of the presbytery be left entirely to the presbytery, with the stipulation that should they agree on their names before the Council adjourns the names will be presented for election, but if they have not been agreed upon by that time they be authorized to select the names of the remainder when found.

On motion, the request was granted.

(The Executive Presbytery, after prayerful deliberation, chose also Geo. A. Chambers, R. L. Erickson and D. H. McDowell as members of the Presbytery).

Co-operation for Missionary Work.

The Conference Committee presented the following resolution for adoption.

WHEREAS, in the providence of God there have sprung up spontaneously in this movement throughout the country, Pentecostal centers, and whereas these places have gathered about them a constituency by the publication of periodicals for the dissemination of Pentecostal truths, and whereas in consequence moneys for missionary purposes are being sent to these several centers and distributed upon the missionary field,

THEREFORE BE IT RESOLVED, That the Presbytery be instructed to seek to bring about a more perfect co-operation among these centers, in the matter of distribution of missionary funds, and the sending out of missionaries, with a view to greater efficiency in each of these various centers.

On motion, after discussion, the resolution was unanimously adopted.

An Effective Publishing Plant.

The Conference Committee recommended the following resolution for adoption:

WHEREAS, the printing press has been one of the principal means whereby the special testimony of great spiritual movements has been most widely and rapidly promulgated, and

WHEREAS, the very life of the papers now owned and controlled by the General Council depends on an equipment which will make them self-supporting, and

WHEREAS, God has used these papers for the last year or more in gathering about \$10,000.00 for foreign missions, thus making them indespensible to foreign missionary work;

THEREFORE BE IT RESOLVED, That the Executive Presbytery be and is hereby authorized to take immediate steps in securing funds through voluntary offerings, subscriptions, or the sale of nonparticipating stock, or in any manner pleasing to God and the Executive Presbytery, of an amount of not less than \$5,000.00 for a publishing equipment to be owned and controlled entirely by the General Council, and to be used solely for the glory of God.

The resolution, on motion and after discussion was unanimously adopted.

FRIDAY, NOV. 20th.

After prayer and the reading of the Word, the chairman called the Council to order and the Conference Committee presented the following resolution for adoption:

The Right Hand of Fellowship Extended.

WHEREAS, some of the brethren in different sections of the country deemed it necessary to form themselves into non-sectarian associations for the purpose of providing a method whereby a better understanding might be had as to who are properly accredited workers,

THEREFORE BE IT RESOLVED, That we commend the spirit and attitude of the brethren in safeguarding the Pentecostal Assemblies and that we recognize these brethren and extend to them the right hand of fellowship in accordance with our constitution.

On motion, the resolution was unanimously adopted, the Council singing, "Blest Be the Tie That Binds."

On motion, Tuesday, Nov. 24th, was set apart by the Council as Missionary Day.

SATURDAY, NOV. 21st.

Resolution on the Work of the Presbytery.

On motion, the following resolution, presented by the Conference Committee to the Council, was adopted:

Resolved, first, That the Executive Presbytery is especially charged with the duty of administering the obligations of the General Council to the young converts, young preachers, and young assemblies in unity with us, and we express the prayerful hope that the ordained ministers everywhere will co-operate with, and render all the assistance in their power to, the Presbyters in the discharge of these arduous labors.

Second. That among other things enjoined by the Word of God upon such officers as our Executive Presbyters, they be expected to travel over the field, at home and abroad, as the Lord may lead, with a view to acquainting themselves and the General Council with conditions everywhere.

Third. That, after consultation with the pastors and officers of the local assemblies, the Presbyters recommend to the General Council which of the local assemblies in unity with us are Scripturally set in order, and also which of said assemblies are not yet so qualified, in order that the General Council, through the Presbytery, may assist in the development of the latter in the will of God.

Fourth. We recognize the right of any assembly of God, scripturally set in order, to conduct all of its congregational affairs without interference from any outside source, and we express the prayerful hope that all such bodies will continue in unity with the General Council, send messengers to its sessions and co-operate in all of its work.

Fifth. That we recommend to those assemblies which are not yet thus scripturally qualified, that they seek the advice and service of the Presbytery and of such brethren as may be able to help them in "setting in order the things that are wanting." Tit. 1:5.

Sixth. That we further recommend that all assemblies which have difficulties of any kind which seriously threaten to cause division in their midst, to seek the help of the Presbytery for advice before the division occurs.

Seventh. Resolved further, That the Executive Presbyters be expected, with such advice from the older ministers throughout the world and of the various district councils as they may be able to obtain, to prepare a list of those ministers in unity with us who by experience and qualifications may justify the General Council in recognizing their ordinaton as Elders, and likewise prepare a list of those ministers and aspirants to the ministry whose experience and qualifications do not warrant their ordination as elders.

We recognize that all ministers of the first division are entitled to perfect freedom in the ministry of the Gospel, with no other ties binding them than those of love, unity and co-operation with the General Body, but recommend to the other class that they submit themselves to the brotherly oversight of the District and General Councils, the Executive Presbytery and such brethren as may be able to assist them. 1 Pet. 5:5.

Eighth. That, wherein any brother be used of God to establish an assembly in a new field he be recognized as the logical overseer or pastor of that flock and that he be encouraged to remain with the same assembly and feed it and care for it until the Lord shall raise up a pastor to take this responsibility and thus relieve him that he may press on to new fields; and if he shall find it needful to go before this is accomplished let him confer with the nearest Presbyter before leaving. Thus we may avoid the disaster that has come to many of the young assemblies that have been left without pastoral care.

Ninth. And, whereas, the recognition by the General Council of the foregoing obligations resting upon it as the representative of the General Assembly of the First Born among us, and the discharge of these world-wide duties by our Executive Presbytery will call for the use and expenditure of large sums of money.

Therefore, be it further Resolved, That we recommend to all saints everywhere having treasures of money or property which they wish to offer to God, in obedience to the command of the Lord Jesus (Math. 6:19), prayerfully consider the offering of such treasures to the Executive Presbytery, in order that there may be no failure of the Church of God to accomplish His full will for lack of means.

We further recommend to the saints everywhere that they diligently adopt the New Testament system and plan of "laying by in store on the first day of the week as the Lord has prospered you" (1 Cor. 16:1-2) and warn them against slothfulness and irregularity in these matters.

In conclusion, we commend the Presbyters and their helpers as they may travel in the discharge of their duties to the saints throughout the world and recommend that offerings be taken in each place where they may visit for the work of the Presbytery.

MONDAY, NOV. 23rd.

A Co-operative Evangelism.

Brother L. C. Hall presented the following resolution, which was unanimously adopted by the Council:

"As a Council, we hereby express our gratitude to God for His great blessing upon the movement in the past. We are grateful to Him for the results attending this forward movement and we commit ourselves and the movement to Him for the greatest evangelism that the world has ever seen. We pledge our hearty co-operation, prayers and help to this end."

On motion, the following resolution was unanimously adopted, that whereas the Stone Church and its people with other assemblies and saints in Chicago have extended to the General Council such hearty hospitality, therefore be it resolved, That the General Council extend a sincere vote of thanks to the saints of the Stone Church and those others who have by their hospitality helped in the work of the Council.

On motion, a tract entitled, "Advice to Young Converts," was, by the Council, ordered to be published.

On motion, the minutes as edited and corrected by the Presbytery, were adopted and approved.

On motion, the Council adjourned until the call of the next General Council by the Presbytery.
