



## PREAMBLE AND RESOLUTION OF CONSTITUTION.

HOT SPRINGS, ARK., April 2-12, 1914.

WHEREAS, God, our Heavenly Father, sent His only Begotten Son, the Lord Jesus Christ, into the world, Who purchased and redeemed fallen man with His own precious blood, and called out of the world and saved a people, of whom He built and established His Church (Assembly of God. Matt. 16:18), upon the foundation of the Apostles and Prophets, Jesus Christ Himself being the Head and Chief Corner-stone (Eph. 2:20), and organized and baptized it with the Holy Spirit, with its government upon His shoulders (Isaiah 9:6-7), said: "The gates of hell shall not prevail against it" (Matt. 16:18); and

WHEREAS, He gave the Holy Inspired Scriptures, (both old and new covenants, Heb. 8:6-13) as the all-sufficient rule for faith and practice, (2 Tim. 3:16), as follows: "All Scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness: That the man of God may be perfect, thoroughly furnished unto all good works," we therefore shall not add to nor take from it (Rev. 22:18); and

WHEREAS, He commanded that there should be no schism (division, sectarianism) in His body, the GENERAL ASSEMBLY (Church) of the first born, which are written in heaven, Heb. 12:23; and

WHEREAS, We recognize ourselves as members of said GENERAL ASSEMBLY OF GOD, (which is God's organism), and do not believe in identifying ourselves as, or establishing ourselves into, a sect, that is a human organization that legislates or forms laws and articles of faith and has unscriptural jurisdiction over its members and creates unscriptural lines of fellowship and disfellowship and which separates itself from other members of the General Assembly (Church) of the first born, which is contrary to Christ's prayer in St. John 17, and Paul's teaching in Eph. 4:1-16, which we heartily endorse:

THEREFORE, BE IT RESOLVED, FIRST, That we recognize ourselves as a GENERAL COUNCIL of Pentecostal (Spirit Baptized) saints from local Churches of God in Christ, Assemblies of God, and various Apostolic Faith Missions and Churches, and Full Gospel Pentecostal Missions, and Assemblies of like faith in the United States of America, Canada and Foreign Lands, whose purpose is neither to legislate laws of government, nor usurp authority over said various Assemblies of God, nor deprive them of their Scriptural and local rights and privileges, but to recognize Scriptural methods and order for worship, unity, fellowship, work and business for God, and to disapprove of all unscriptural methods, doctrines and conduct, and approve of all Scriptural truth and conduct, endeavoring to keep the unity of the Spirit in the bonds of peace, until we all come into the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fulness of Christ, and to walk accordingly, as recorded in Eph. 4:17-32.

RESOLVED, SECOND, That we recognize all the above said Assemblies of various names, and when speaking of them refer to them by the general Scriptural name "Assemblies of God;" and recommend that they all recognize themselves by the same name, that is, "Assembly of God" and adopt it as soon as practicable for the purpose of being more Scriptural and also legal in transacting business, owning property, and executing missionary work in home and foreign lands, and for general convenience, unity and fellowship.

## PROCEEDINGS OF ST. LOUIS COUNCIL, OCT. 1-7, 1916.

---

The General Council opened Sunday morning, October 1st, with a most precious service in which the presence of the Lord was very evident. After singing and prayer, the message of the morning was brought to us by Elder D. W. Kerr of Cleveland, Ohio. The burden of the message related to the ever present virtue of the sacrifice of Christ, represented by the bread and the fruit of the vine. At the conclusion of the message, as the brethren from many parts of the country gathered around the Lord's table to partake of the communion, the fire of God fell upon them and their hearts burst out in praise and adoration, singing in the Spirit, weeping and laughing and praising God. Truly how wonderful it is for brethren to dwell together in unity.

The afternoon message was brought to us by Elder A. P. Collins of Fort Worth, Texas, urging upon us the necessity of being ready when the Bridegroom comes, being found at our post in the harvest field laboring for the lost.

The evening message was delivered by Brother Andrew D. Urshan, our Pentecostal Persian brother, lately returned from Persia and Russia. His theme was "Jesus, the all-sufficient One." How our hearts burned within us as he spake. At the close, the altar was filled with seekers after God and the power of God was mightily present.

### **Monday Morning, October 2nd.**

The first business session of the Council was called to order by the Chairman, J. W. Welch, at 10 a. m. The Council went before God in prayer to invoke His divine aid in the deliberations, that God might be glorified and all things done according to the Scriptures, to the glory of His name.

The Chairman then delivered the opening address, setting forth the status of the Council and the purposes for which we had come together. In this address he said that this Council is called together in the name of the Lord Jesus Christ as members of His body. That we are also assembled in the name of the Commonwealth of Missouri, recognizing the fact that we are a corporate body in continuous existence. That we are gathered Scripturally and also legally. That we shall continue to be legal so long as we remain within the constitution on which our Council is based. That we shall be Scriptural so long as we hold to the Word of God in the Spirit of Jesus. The Chairman then made some recommendations based on his experience as Chairman of the Council and as Editor of the Weekly Evangel during the past year, which recommendations were largely incorporated in the following actions of the Council.

### **ENROLLMENT.**

On motion, a committee to receive and pass upon names to be admitted to the roster was appointed, consisting of D. B. Rickard, B. F. Lawrence and F. F. Bosworth.

### **COMMITTEE ON RESOLUTIONS.**

On motion, a Council Committee on Resolutions was appointed, consisting of five brethren, viz., E. N. Bell, S. A. Jamieson, D. W. Kerr, T. K. Leonard and Stanley H. Frodsham.

### **REPORTS FROM THE FIELD.**

Inasmuch as the Council Committee on Resolutions had not had time to prepare suggested resolutions for presentation on the floor, some time was given over to reports from the field. Dr. Murcutt and John Mark Levy (two



converted Hebrews) brought up a discussion of Pentecostal evangelism among the Jews. Foreign missionary work was also touched upon. Brother Aubrey gave an interesting report of his work in a Gospel boat on the three great rivers, among the fishermen, which aroused some interest.

The Committee appointed to compile the roster reported the names of all members of the Council present, and on motion, these names, together with others which might be added later, were adopted as the Council Roll.

### **EVANGELISM.**

A large part of the afternoon was then given up to the discussion of Evangelism, some very pointed remarks being made by a number of the brethren on this important subject. A. P. Collins, E. N. Richey and T. K. Leonard were the principal speakers on this subject. One remark by A. P. Collins was of particular significance. He said, "The thing that brought the one hundred and twenty disciples into unity was the fact that Jesus commanded them to go into all the world and preach the Gospel to every creature." The thought was brought out that when we today get the burden of going into all the world as the disciples did, at the command of Jesus, that we also will be brought into great unity in the work of soul saving and God will pour out His Spirit upon us in Pentecostal fulness.

On motion, the business session for the day adjourned until the following morning.

The evening service was characterized by a goodly number of people present, when Brother F. F. Bosworth brought the message on Evangelism. His message was blessed of God and a number found their way to the altar where a blessed time followed.

### **Tuesday Morning, October 3rd.**

The Council was called to order at 9:30 and a season spent in prayer before God.

Reports from the field were heard from J. H. James of Kansas, Jacob Miller of Arkansas, Lee Floyd of Louisiana, E. L. Banta and B. F. Lawrence of Southern Missouri. The report of the Southern Missouri work was particularly interesting in that it showed that about seventy ministers (men and women) are in hearty co-operation in that section with most blessed results.

The Council Committee presented a number of resolutions which were discussed, amended and adopted as follows:

### **THE GENERAL PRESBYTERY AND THE EXECUTIVE PRESBYTERY.**

RESOLVED, That this Council select as many representative men in various sections of the home and foreign fields as it deems advisable as *General Presbyters* to represent this Council in all the phases of its work and in-

terests in their respective fields; and that five of these, two of which shall be the Chairman and the Secretary of the Council, be appointed as an *Executive Presbytery*, which shall hold as a perpetual trust the Gospel Publishing House and all other properties of the General Council, to meet together as often as necessary in executing the work of the General Council; and that two of the Executive Presbyters serve one year, two of them two years, and one three years, or until their successors are elected, who shall hereafter be elected for three years each; and that in case of a vacancy for any cause in the Executive Presbytery, the remaining members of the Executive Presbytery are hereby authorized to fill said vacancy, also to add at any time such members to the General Presbytery as they shall deem necessary to efficiency.

### **THE PUBLISHING INTERESTS.**

RESOLVED, That the Gospel Publishing House, with all its interests, including all papers and periodicals, be and is hereby committed permanently into the hands of the Executive Presbytery to supervise and direct, also to appoint such help as is needed personally to conduct the same.

### **STANDING CREDENTIAL COMMITTEE.**

RESOLVED, That the Chairman and Secretary of the Executive Presbytery constitute a Credential Committee, and that the Council hereby authorizes them to bring out a new form of credential certificate in keeping with the Constitution and fundamental principles of the Council, and to issue annual certificates of fellowship to all in good standing, and that all ministers holding credentials with the General Council be requested to send in their old credentials at once to be exchanged for the new form, and on account of the increased expenditure incurred, and for the upkeep of the General Office, they are requested to send in an offering of one dollar each, and that each year hereafter, an annual fee of fifty cents be asked for to cover the cost of the fellowship certificate.

### **PUBLISHING HOUSE AND GENERAL COUNCIL OFFICE SEPARATED.**

RESOLVED, That the Executive Presbytery be and is hereby authorized to separate the General Council office matters from the Gospel Publishing House matters by opening up a separate office for the General Council as soon as it deems it practicable to do so.

### **ENDORSEMENT OF MISSIONARIES.**

RESOLVED, That all missionaries going out to the foreign field who desire the endorsement of this General Council and its aid, by having it divide among them the undesignated funds coming into our hands, shall report

to the Executive Presbytery, and receive its approval before leaving this country. Otherwise this Council will assume no responsibility for their going out or for their support after arrival upon the field. That in all cases where there are representative Pentecostal missionaries on the field who do not seek such approval, we will nevertheless forward to them all funds coming into our hands designated for them.

### **ON ORDINATIONS.**

RESOLVED, That the General Council strongly urges all ministers and assemblies not to ordain any candidates to the full Gospel ministry except upon the approval of two or more leading ministers, or a General Presbyter, or a District Council.

The Council Committee presented a partial statement of fundamental truths which was received. After considerable discussion the statement was referred to the committee for revision and presentation the following day.

On motion the Council adjourned until the following day.

The evening message was given by Wm. Black on the rewards of the saints and the judgment of the wicked.

### **Wednesday Morning, October 4th.**

On motion, Thursday evening was set apart by the Council for heart talks by the visiting returned missionaries.

The Statement of Fundamental Truths was taken up and further discussed. Each item was discussed separately and passed upon. The Complete Statement appears elsewhere in the minutes.

In the evening, a searching message on our responsibility to God was delivered to a crowded house by our brother Robert A. Brown of New York.

### **Thursday Morning, October 5th.**

The session opened with prayer, after which the discussion of the Statement on Fundamentals was continued at the point where it left off the day before. Several items were amended and adopted.

On motion, the following resolutions were adopted:

### **PAYING TITHES.**

RESOLVED, That this Council hereby urges all its ministers to teach their people the duty of paying tithes to God, and to turn them over regularly as much as is needed to the support of their local ministry; and any surplus, or where there is no local ministry, to their respective headquarters, for the spread of the Gospel throughout the world. According to the Scriptures, tithes are to go to the support of the ministry, and not to charity and other purposes.



## **VIOLATIONS OF MINISTERIAL COURTESY.**

RESOLVED, That all discourteous conduct is disapproved and that all ministers are advised against interfering with others who may have charge of an assembly, whether it be by going in upon the work without consent of the one in charge or by such correspondence with the members of the assembly as will affect the influence of the leader. All correspondence which concerns the whole assembly, such as visiting that field, holding meetings, etc., should be addressed to the one in charge, not to private members. When there is no pastor, letters concerning the work should be addressed to the deacons or elders of the Assembly.

Any minister who so offends should be subjected to a scriptural treatment as an offender, and it is recommended that it be given him by the local authorities, or the District Council, or if there be none, by the Executive Presbytery of the General Council. Such matters will seriously affect the granting of annual Fellowship Certificates and may be the basis of their recall.

## **RESOLUTION ON BAPTISMAL FORMULA.**

RESOLVED, That since the words in Matth. 28:19 and the words in Acts 2:38 were both inspired of God, we hereby disapprove of contending for the one to the exclusion of or as against the other, because confusion and a party spirit are sure to follow such unscriptural conduct. This Council therefore recommends that all our preachers include in their formula used in connection with the act of baptism the words used by Jesus in Matth. 28:19.

## **NOMINATING COMMITTEE.**

On motion, the chair appointed a nominating committee of three to nominate five of the General Presbyters, who in turn were to become a further nominating committee. The chair appointed on said committee Andrew L. Fraser, E. N. Bell and S. A. Jamieson.

## **ELECTION OF GENERAL PRESBYTERS.**

The nominating committee reported the names of J. W. Welch, A. P. Collins, D. W. Kerr, T. K. Leonard and R. A. Brown, which were received by the Council, and, on motion, were elected by acclamation. The five General Presbyters thus elected formed a further nominating committee, who presented the names of the following brethren, who were elected by ballot: S. A. Jamieson, Stanley Frodsham, D. H. McDowell, Joseph Tunmore, J. T. Boddy, G. N. Eldridge, J. R. Flower, E. N. Bell, E. N. Richey, E. R. Fitzgerald and D. B. Rickard.

On motion, the Council adjourned until the following morning.

The evening service was given up to a hearing of the missionaries present. A cash offering was taken amounting to \$116.50. Those who spoke

were James Harvey and Sister Radford of India, Phoebe Holmes, Geo. M. Kelley and Miss Mattie Ledbetter of China, and Andrew D. Urshan of Persia. The most intense interest was manifest all through the service which was signally blessed of God.

### **Friday Morning, October 5th, 1916.**

After devotional exercises, the Council was called to order by the Chairman.

Further items in the Statement of Fundamental Truths were discussed and adopted. See Complete Statement elsewhere in the minutes.

### **ASSOCIATE PRESBYTERS.**

On motion, the names of all the chairmen of District Councils in co-operative fellowship with this General Council, who are not already on the General Presbytery, were recognized, by virtue of their office, as Associate Presbyters. On motion, Jas. O. Savell of Landing, Miss., was also elected as Associate Presbyter.

On motion, the chair was directed to appoint a committee of three on the nomination of a chairman and secretary for the Council, and on the nomination of the five Executive Presbyters.

On motion, the Council adjourned until morning.

The evening service was crowded again as were all the night services during the week. Brother A. G. Garr of Los Angeles, Calif., delivered a powerful message on the wrath of God, and some who came to the altar touched the Lord amid great demonstrations of victory and blessing.

### **Saturday Morning, October 6th.**

The Council came to order at 9:00 o'clock and Elder D. W. Kerr of Cleveland, Ohio, took the floor by special request and gave an address on the Deity of the Lord Jesus Christ, which was received with great profit to all.

### **THE EXECUTIVE PRESBYTERY.**

The nominating committee presented the following names to the Council, to constitute the Executive Presbytery: J. W. Welch, Chairman, Stanley H. Frodsham, Secretary, J. R. Flower, D. W. Kerr and D. B. Rickard; Stanley H. Frodsham and D. B. Rickard to serve for one year, J. R. Flower and D. W. Kerr for two years, and J. W. Welch for three years, their term of office to commence October 15, 1916.

On motion, these brethren were unanimously elected to the Executive Presbytery.

On motion, further items on the statement of Fundamental Truths were read, discussed and adopted by the Council. The Completed Statement, as revised and edited by the Council Committee on Resolutions and approved by the Executive Presbytery, was adopted as follows:

## A STATEMENT OF FUNDAMENTAL TRUTHS APPROVED BY THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD, OCTOBER 2-7, 1916.

This Statement of Fundamental Truths is not intended as a creed for the Church, nor as a basis of fellowship among Christians, but only as a basis of unity for the ministry alone (i. e., that we all speak the same thing, 1 Cor. 1:10; Acts 2:42). The human phraseology employed in such statement is not inspired nor contended for, but the truth set forth in such phraseology is held to be essential to a full Gospel ministry. No claim is made that it contains all truth in the Bible, only that it covers our present needs as to these fundamental matters.

### 1. THE SCRIPTURES INSPIRED.

The Bible is the inspired Word of God, a revelation from God to man, the infallible rule of faith and conduct, and is superior to conscience and reason, but not contrary to reason. 2 Tim. 3:15, 16; 1 Pet. 2:2.

### 2. THE ONE TRUE GOD.

The one true God has revealed Himself as the eternally self-existent, self-revealed "I AM;" and has further revealed Himself as embodying the principles of relationship and association, i. e., as Father, Son and Holy Ghost. Deut. 6:4; Mark 12:29; Isa. 43:10, 11; Matth. 28:19.

### 3. MAN, HIS FALL AND REDEMPTION.

Man was created good and upright; for God said, "Let us make man in our image and in our likeness." But man, by voluntary transgression, fell, and his only hope of redemption is in Jesus Christ the Son of God. Gen. 1:26-31; 3:1-7; Rom. 5:12-21.

### 4. THE SALVATION OF MAN.

#### (a) Conditions to Salvation.

The grace of God that brings salvation to all men has appeared through the preaching of repentance toward God and faith toward the Lord Jesus Christ; whereupon man is saved by the washing of regeneration and renewing of the Holy Ghost which is shed upon him richly through Jesus Christ our Saviour; and, having been justified by grace through faith, he becomes an heir of God according to the hope of eternal life. Tit. 2:11; Rom. 10:13-15; Luke 24:47; Titus 3:5-7.

#### (b) The Evidences of Salvation.

The inward evidence to the believer of his salvation, is the direct witness of the Spirit. Rom. 8:16. The outward evidence to all men is a life of righteousness and true holiness, Luke 1:73-75; Titus 2:12-14; the fruit of the Spirit, Gal. 5:22, and brotherly love, Jno. 13:35; Heb. 13:1; 1 Jno. 3:14.

### 5. THE PROMISE OF THE FATHER.

All believers are entitled to, and should ardently expect, and earnestly seek the promise of the Father, the baptism in the Holy Ghost and fire, according to the command of our Lord Jesus Christ. This was the normal experience of all in the early Christian Church. With it comes the endowment of power for life and service, the bestowment of the gifts and their uses in the work of the ministry. Luke 24:49; Acts 1:4; 1:8; 1 Cor. 12:1-31.



## **6. THE FULL CONSUMMATION OF THE BAPTISM IN THE HOLY GHOST.**

The full consummation of the baptism of believers in the Holy Ghost and fire, is indicated by the initial sign of speaking in tongues, as the Spirit of God gives utterance. Acts 2:4. This wonderful experience is distinct from and subsequent to the experience of the new birth. Acts 10:44-46; 11:14-16; 15:8, 9.

## **7. ENTIRE SANCTIFICATION, THE GOAL FOR ALL BELIEVERS.**

The Scriptures teach a life of holiness without which no man shall see the Lord. By the power of the Holy Ghost we are able to obey the command, "be ye holy for I am holy." Entire sanctification is the will of God for all believers, and should be earnestly pursued by walking in obedience to God's Word. Heb. 12:14; 1 Pet. 1:15, 16; 1 Thess. 5:23, 24; 1 Jno. 2:6.

## **8. THE CHURCH A LIVING ORGANISM.**

The Church is a living organism; a living body; yea the body of Christ; a habitation of God through the Spirit, with divine appointments for the fulfillment of her great commission. Every local assembly is an integral part of the General Assembly and Church of the First-born, written in heaven. Eph. 1:22, 23; 2:22; Heb. 12:23.

## **9. THE MINISTRY AND EVANGELISM.**

A divinely called and a Scripturally ordained ministry for the evangelization of the world, is the command of the Lord, and the chief concern of the Church. Mk. 16:15-20; Eph. 4:11-13.

## **10. THE LORD'S SUPPER.**

The Lord's Supper, consisting of the elements, bread and the fruit of the vine, is the symbol expressing our sharing the divine nature of our Lord Jesus Christ, 2 Pet. 1:4; a memorial of his suffering and death, 1 Cor. 11:26; and a prophecy of His second coming, 1 Cor. 11:26; and is enjoined on all believers "until He comes."

## **11. BAPTISM IN WATER.**

The Ordinance of Baptism by a burial with Christ should be observed as commanded in the Scriptures, by all who have really repented and in their hearts have truly believed on Christ as Saviour and Lord. In so doing, they have the body washed in pure water as an outward symbol of cleansing while their heart has already been sprinkled with the blood of Christ as an inner cleansing. Thus they declare to the world that they have died with Jesus and that they have also been raised with Him to walk in newness of life. Math. 28:19; Acts 10:47-48; Rom. 6:4; Acts 20:21; Heb. 10:22.

## **12. DIVINE HEALING.**

Deliverance from sickness is provided for in the atonement, and is the privilege of all believers. Isa. 53:4, 5; Matth. 8:16, 17.

## **13. THE ESSENTIALS AS TO THE GODHEAD.**

### **(a) Terms Explained.**

The terms "Trinity" and "Persons," as related to the Godhead, while not found in the Scriptures, yet are words in harmony with Scripture, whereby we may convey to others our immediate understanding of the doctrine of Christ respecting the Being of God, as distinguished from "gods many and lords many." We, therefore, may speak with propriety of the Lord our God, who is One Lord, as a Trinity or as one Being of three Persons, and still be absolutely Scriptural. (Examples: Matth. 2:6; 8:16, 17; Acts 15:15-18.)

(b) **Distinction and Relationship in the Godhead.**

Christ taught a distinction of Persons in the Godhead which he expressed in specific terms of relationship, as Father, Son, and Holy Ghost; and that this distinction and relationship, as to its existence, is an eternal fact, but as to its mode it is **inscrutable** and **incomprehensible**, because **unexplained**. (That is, it is not explained as to how there can be three persons in the Godhead.) (Luke 1:35; 1 Cor. 1:24; Matth. 11:25-27; 28:19; 2 Cor. 13:14; 1 Jno. 1:3, 4.)

(c) **Unity of the One Being of Father, Son and Holy Ghost.**

Accordingly, therefore, there is **that** in the Father which constitutes Him **the Father** and not the Son; there is **that** in the Son which constitutes Him **the Son** and not the Father; and there is **that** in the Holy Ghost which constitutes him **the Holy Ghost** and not either the Father or the Son. Wherefore, the Father is the Begetter; the Son is the Begotten; and the Holy Ghost is the one proceeding from the Father and the Son. Therefore, because these three eternally **distinct** and **related** persons in the Godhead are in a state of **unity**, there is but one Lord God Almighty and His name one. Jno. 1:18; 15:26; 17:11, 21; Zech. 14:9.

(d) **Identity and Co-operation in the Godhead.**

The Father, the Son and the Holy Ghost are never **identical** as to **Person**; nor **confused** as to **relation**; nor **divided** in respect of the Godhead; nor **opposed** as to **co-operation**. The Son is **in** the Father and the Father is **in** the Son as to relationship. The Son is **with** the Father and the Father is **with** the Son as to fellowship. The Father is not **from** the Son, but the Son is **from** the Father, as to authority. The Holy Ghost is **from** the Father and the Son proceeding, as to nature, relationship, co-operation and authority. Hence, neither Person in the Godhead either exists or works separately or independently of the others. Jno. 5:17-30.

(e) **The Title, Lord Jesus Christ.**

The appellation "Lord Jesus Christ" is a proper name. It is never applied, in the New Testament, either to the Father or to the Holy Ghost. It therefore belongs exclusively to the **Son of God**. Rom. 1:1-3, 7; 2 Jno. 3.

(f) **The Lord Jesus Christ, God with us.**

The Lord Jesus Christ, as to His divine and eternal nature, is the proper and only Begotten of the Father; but, as to His human nature, He is the proper Son of Man. He is, therefore, acknowledged to be both God and man: who, because He is God and man, is "Immanuel," God with us. Matth. 1:23; 1 Jno. 4:2, 10, 14; Rev. 1:13, 14-17.

(g) **The Title, Son of God.**

Since the name "Immanuel" embraces both God and man in the one Person, our Lord Jesus Christ, it follows that the title, Son of God, describes His proper Deity, and the title, Son of Man, His proper humanity. Therefore, the title, Son of God, belongs to the **order of eternity**, and the title, Son of man, to the **order of time**. Matth. 1:23, 21; 2 Jno. 3; 1 Jno. 3:8; Heb. 7:3; 1:1-13.

(h) **Transgression of the Doctrine of Christ.**

Wherefore, it is a transgression of the Doctrine of Christ to say that Jesus Christ derived the title, Son of God, either from the fact of the incarnation, or because of His relation to the economy of redemption. There-

fore, to deny that the Father is a real and eternal Father, and that the Son is a real and eternal Son, is a denial of the distinction and relationship in the Being of God; a denial of the Father and the Son; and a **displacement** of the truth that Jesus Christ is come in flesh. 2 Jno. 9; Jno. 1:1, 2, 14, 18, 29, 49; 8:57, 58; 1 Jno. 2:22, 23; 4:1-5; Heb. 12:3, 4.

(i) **Exaltation of Jesus Christ as Lord.**

The Son of God, our Lord Jesus Christ, having by himself purged our sins, sat down on the right hand of the Majesty on high; angels and principalities and powers having been made subject unto Him, And, having been made both Lord and Christ, He sent the Holy Ghost that we, in the name of Jesus, might bow our knees and confess that Jesus Christ is Lord to the glory of God the Father until the end, when the Son shall become subject to the Father that God may be all in all. Heb. 1:3; 1 Pet. 3:22; Acts 2:32-36; Rom. 14:11; 1 Cor. 15:24-28.

(j) **Equal honor to the Father and the Son.**

Wherefore, since the Father has delivered all judgment unto the Son, it is not only the **express duty** of all things in heaven and in earth to bow the knee, but it is an **unspeakable** joy in the Holy Ghost to ascribe unto the Son all the attributes of Deity, and to give him all the honor and the glory contained in all the names and titles of the Godhead, (except those which express relationship. See paragraphs b, c and d) and thus honor the Son even as we honor the Father. Jno. 5:22, 23; 1 Pet. 1:8; Rev. 5:6-14; Phil. 2:9, 8; Rev. 7:9, 10; 4:8-11.

#### 14. THE BLESSED HOPE.

The Resurrection of those who have fallen asleep in Christ, the rapture of believers which are alive and remain, and the translation of the true church, this is the blessed hope set before all believers. 1 Thess. 4:16, 17; Rom. 8:23; Tit. 2:13.

#### 15. THE IMMINENT COMING AND MILLENIAL REIGN OF JESUS.

The premillennial and imminent coming of the Lord to gather His people unto Himself, and to judge the world in righteousness while reigning on the earth for a thousand years is the expectation of the true Church of Christ.

#### 16. THE LAKE OF FIRE.

The devil and his angels, the Beast and false prophet, and whosoever is not found written in the Book of Life, the fearful and unbelieving, and abominable, and murderers and whoremongers, and sorcerers, and idolators and all liars shall be consigned to everlasting punishment in the lake which burneth with fire and brimstone, which is the second death.

#### 17. THE NEW HEAVENS AND NEW EARTH.

We look for new heavens and a new earth wherein dwelleth righteousness. 2 Pet. 3:13; Rev. 21 and 22.

---

### UNITY IN THE MINISTRY.

Inasmuch as unity among ministers is dependent upon their speaking the same thing on all fundamental matters (1 Cor. 1:10), the Credential Committee is hereby instructed to ask each applicant of the ministry for Credentials or for a Certificate of Fellowship whether he recognizes and accepts the



truth in the Statement of Fundamentals to the extent that he will endeavor, with all lowliness and meekness and loving forbearance, to keep the unity of the Spirit in the bond of peace, till we all come in the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fulness of Christ. Eph. 4:2, 3, 13.

This Committee is hereby instructed to issue credentials to those who agree, and to refuse to those who seriously disagree; and that in the case of minor disagreements, the committee is instructed to use its own discretion in the matter; and that in the case of violations of the agreement and the causing of trouble and division, they are instructed to deal with the case as directed in the item pertaining to Violations of Ministerial Courtesy.

### **CORRECTION AND REVISION.**

The original items of the Statement of Fundamental Truths were referred to the Council Committee for revision and correction by the following resolution:

RESOLVED, That the whole statement of Fundamental Truths, with all recommendations passed, be recommitted to the Council Committee on Resolutions for such corrections and revisions as shall make them consistent, and to arrange them in such proper order and form as will appear best in print. That such corrected statement be submitted to the Executive Presbytery for inspection and acceptance, and that this body hereby authorizes said Executive Presbytery to pass finally on the same as a whole in behalf of this body before the same is printed as the acts of this Council.

On motion, the following resolution was adopted:

RESOLVED, That this General Council hereby authorizes the Chairman and Secretary of said Council, in consultation with the Executive Presbytery, to put the standing debts of the Publishing House or of this Council into such legal form as heretofore have only been morally binding by the Agreement of the Presbytery last year in recognizing and authorizing said debts.

### **BIBLE SCHOOLS.**

On motion, the following resolution was adopted: RESOLVED, That the Executive Presbytery is hereby authorized to take under advisement the matter of encouraging Bible Schools for young preachers in various parts of the country; that they take such steps in this direction as to time and places as in their power and judgment are practicable.

### **FUND FOR MAINTENANCE OF GENERAL OFFICE.**

On motion, it was recommended that every pastor and evangelist give out of his own income, or send through his influence, one dollar (\$1.00) per

month to help in the great expense of the Publishing interests and the maintenance of the General Office of the Council during the year.

On motion, a vote of appreciation was directed to the Chairman and the Secretary for their faithful work in this Council, and to their wives and helpers who have ministered so faithfully to the brethren at the Evangel Home.

On motion, a vote of thanks was tendered to the acting pastor of Bethel Chapel, Bro. A. T. Rape, and his worthy wife, for their untiring efforts to provide for the comfort of the visiting brethren at this General Council.

On motion, the reading, editing and publishing of the minutes and all other unfinished business of the Council and Presbytery was committed to the Executive Presbytery.

On motion, the minutes of this Council, as edited by the Executive Presbytery, were adopted.

On motion, the Council adjourned until again called by the Chairman.
