# COMBINED MINUTES OF THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD IN THE UNITED STATES OF AMERICA AND FOREIGN LANDS — 1914-1925.

## PREAMBLE AND RESOLUTIONS OF CONSTITUTION

Whereas, God, our Heavenly Father, sent His only begotten Son, the Lord Jesus Christ, into the world, who purchased and redeemed fallen man with His own precious blood, and called out of the world and saved a people, of whom He built and established His Church (Assembly of God. Matt. 16:18), upon the foundation of the Apostles and Prophets, Jesus Christ Himself being the Head and Chief Cornerstone (Eph. 2:20), and organized and baptized it with the Holy Spirit, with its government upon His shoulders (Isa. 9:6, 7), and said: "The gates of hell shall not prevail against it" (Matt. 16:18); and

Whereas, He gave the Holy Inspired Scriptures (both old and new covenants, Heb. 8:6-13) as the all-sufficient rule for faith and practice (2 Tim. 3:16), saying: "All Scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness: that the man of God may be perfect, thoroughly furnished unto all good works," we therefore shall not add to nor take from them (Rev. 22:18); and

Whereas, He commanded that there should be no schism (division, sectarianism) in His Body, the GENERAL ASSEMBLY (Church) of the first born, which are written in heaven (Heb. 12:23); and

Whereas, We recognize ourselves as members of said GENERAL ASSEMBLY OF GOD (which is God's organism), and do not believe in identifying ourselves as, or establishing ourselves into, a sect, that is a human organization that legislates or forms laws and



articles of faith and has unscriptural jurisdiction over its members and creates unscriptural lines of fellowship and disfellowship and which separates itself from other members of the General Assembly (Church) of the first born. which is contrary to Christ's prayer in St. John 17, and Paul's teaching in Eph. 4: 1-16, which we heartily endorse; therefore, be it

Resolved: First, That we recognize ourselves as a GENERAL COUNCIL of Pentecostal (Spirit Baptized) saints from local Churches of God in Christ, Assemblies of God, and various Apostolic Faith Missions and Churches, and Full Gospel Pentecostal Missions and Assemblies of like faith in the United States of America and Foreign Lands, whose purpose is neither to legislate laws of government, nor usurp authority over said various Assemblies of God, nor deprive them of their Scriptural and local rights and privileges, but to recognize Scriptural methods and order for worship, unity, fellowship, work and business for God, and to disapprove of all unscriptural methods, doctrines and conduct, and approve of all Scriptural truth and conduct, endeavoring to keep the unity of the Spirit in the bonds of peace, until we all come into the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ, and to walk accordingly, as recorded in Eph. 4: 17-32.

Resolved: Second, That we recognize all the above said Assemblies of various names, and when speaking of them refer to them by the general Scriptural name, "Assemblies of God," and recommend that they all recognize themselves by the same name, that is, "Assembly of God" and adopt it as soon as practicable for the purpose of being more Scriptural and also legal in transacting business, owning property, and executing missionary work in home and foreign lands, and for general *convenience, unity and fellowship.*

### **Parliamentary Order**

On motion it was agreed that the Council should be governed by Parliamentary usage, under the guidance of the Holy Spirit and according to the Word of God.

## **Roster Committee**

At each meeting of the General Council the chair shall appoint a Roster Committee of three, which shall be authorized to pass upon the eligibility of all names reported as delegates, and to prepare a roll of all those approved. Any complaints as to delegates being received should be made to this committee.

## **Delegates from Local Assemblies**

Resolved, That each assembly in co-operation with the Council, or desiring to co-operate, should send at least one delegate each year, and that the assembly is especially invited to send its pastor or some other representative, chosen by the assembly, as a delegate to each meeting of the General Council. Each assembly should aid the pastor on the expenses of the trip.

## **Preacher Delegates**

All men and women holding up-to-date credentials from the General Council, when in attendance, shall be recognized as full delegates.

## **Standing Committees**

It was moved and carried that the various Standing Committees should act during the Council sessions, and that all resolutions be referred to these several committees according to their subject matter and that these committees report on the same.

## **Chairman and Secretary Advisory to Committees**

It was moved and carried that the Chairman and Secretary of the General Council be recognized as members ex-officio of all Standing Committees, and that such committees call for their advice when needed.

## **Duties of General Officers**

The following suggestions have been made and adopted as a guide to the several officers of the Council as to their duties in the same. There shall be at least three such officers, a Chairman, a Secretary and a Missionary Secretary.

## **Duties of the Chairman**

In addition to the duties already or elsewhere de-



fined, the following shall be expected of the Chairman of the General Council:

1. To preside at the meetings of the Council.
2. To be the Head of the General Office, and to supervise all the work of that office from one Council meeting till the next.
3. To be Chairman of the Credential Committee, and to sign all credentials.
4. To be Chairman of the Executive Presbytery, and to receive all communications directed to that body.
5. To be general superintendent of all work on the field conducted in behalf of the General Council and its work, and to encourage Bible and Missionary Conventions throughout the country.
6. To call temporarily for the return of Credentials on the part of any offending minister in cases where requested to do so by the Credential Committee.
7. Finally to perform any other functions usual and customary as Chairman or such as may be directed by this Council or by the Executive Presbytery.

#### **Duties of the Assistant Chairman**

1. To assist the Chairman.
2. To preside at meetings in the absence of the Chairman.
3. To be a member of the Credential Committee.
4. To assist the Chairman in the general superintendence of the work on the field conducted in behalf of the General Council and its work, and to encourage Bible and Missionary Conventions throughout the country.
5. Finally, to perform any other functions under the supervision of the Chairman, or such as may be directed by this Council or by the Executive Presbytery.

#### **Duties of the Secretary**

1. To make proper minutes of the meeting of the General Council and to publish the same as approved and directed by the Executive Presbytery.
2. To do such work as secretary of the Credential Committee as may be directed by the Chairman or may be mutually agreed upon.

3. To be a member of the Credential Committee, and to sign all credentials.

4. To keep the books, and conduct all the work of his office in co-operation with and under the general oversight of the Chairman.

5. To perform such other functions as are customary or as may be directed by this Council or the Executive Presbytery.

### **Duties of the Missionary Secretary.**

1. To act as head of the Missionary department under the supervision of the Missionary Committee.

2. To keep a record of all decisions of the Missionary Committee and of all official acts of the Missionary department.

3. To conduct all correspondence with prospective Missionaries and with those already out on the field.

4. To conduct the Missionary columns in the Pentecostal Evangel from Missionary letters and reports.

5. To represent the General Council in all relationships with Governments or authorities where our Missionary work is involved.

6. To direct the Missionary activities of the Assemblies of God under the supervision of the Missionary Committee.

7. To receive all Missionary funds which are donated for the support of the Missionary activities of the Assemblies of God.

8. To distribute all Missionary funds as directed by the donors or by the Missionary Committee.

9. To keep such records of all funds received and disbursed as will safeguard the funds from loss enroute to the field.

10. To acknowledge in the Pentecostal Evangel all funds received for Missionary work.

11. To conduct all correspondence with the Missionaries or the home field which pertains to the receipt and disbursement of Missionary offerings.

12. To act as purchasing agent for missionary sup-



plies under the supervision of the Missionary Committee.

13. Finally, to perform such other functions as may be directed by the Missionary Committee.

### **The General Presbytery and the Executive Presbytery**

Resolved, That this Council select as many representative men in various sections of the home field as it deems advisable as GENERAL PRESBYTERS to represent this Council in all the phases of its work and interests in their respective fields; and that five of these, together with the Chairman, Assistant Chairman, Secretary of the Council, and Missionary Secretary, nine in all, be elected as an EXECUTIVE PRESBYTERY, which shall hold as a perpetual trust the Gospel Publishing House and all other properties of the General Council, to meet together as often as necessary in executing the work of the General Council; and that the Chairman, Assistant Chairman, Secretary of the Council and Missionary Secretary shall serve for the term of their office and the others to serve for four years each, or until their successors are elected. And that, in case of a vacancy for any cause in the Executive Presbytery, the remaining members of the Executive Presbytery are hereby authorized to fill said vacancy, also to add at any time such members to the General Presbytery as they shall deem necessary to efficiency.

### **District Chairmen**

On motion, the names of all the chairmen of District Councils in co-operative fellowship with this General Council were recognized, by virtue of their office, as General Presbyters. (1925)

### **Retiring District Chairmen (1925)**

Moved and carried that in case of the election of a new district chairman in the interim between General Council sessions, that the new district chairman by virtue of his office shall become a member of the General Presbytery, and the retiring chairman shall no longer be a member of said General Presbytery.

## **Qualifications of Presbyters**

Whereas, It seems expedient to define a standard of qualification for General Presbyters, be it

Resolved, That only men of mature experience and ability, whose life and ministry are above question, shall be eligible to the office of General Presbyter, and that such qualifications, rather than location, determine their eligibility.

## **Consulting the General Presbytery**

The following resolution was adopted:

Resolved, That in all matters of great importance, the Executive Presbytery communicate with the members of the General Presbytery before any final decision is reached, or final action is taken by the Executive Presbytery.

## **The Work of the General Presbytery**

Resolved, First: That the General Presbytery is especially charged with the duty of administering the obligations of the General Council to the young converts, young preachers, and young assemblies in unity with us; and we express the prayerful hope that the ordained ministers everywhere will co-operate with, and render all the assistance in their power to, the Presbyters in the discharge of these arduous labors.

Second: That among other things enjoined by the Word of God upon such officers as our General Presbyters, they be expected to travel over the field, at home and abroad, as the Lord may lead, with the view to acquainting themselves and the General Council with conditions everywhere.

Third: That after consultation with the pastors and officers of the local assemblies, the Presbyters, or officers of the District Council, where such exist, recommend to the General Council, which of the local assemblies in unity with us are Scripturally set in order, and which also of said assemblies are not yet so qualified, in order that the General Council, through the Presbytery and the District Councils, may assist in the development of the latter in the will of God.

Fourth: We recognize the right of any Assembly of God, Scripturally set in order, to conduct all its con-



gregational affairs without interference from any outside source, and we express the prayerful hope that all such local bodies will continue in unity with the General Council, send messengers to its sessions and co-operate in all of its work.

Fifth: That we recommend to those assemblies which are not thus Scripturally qualified that they seek the advice and service of the Presbytery, or the officers of the District Councils where such exist, and of such brethren as may be able to help them in "setting in order the things that are wanting" (Tit. 1:5).

Sixth: That we further recommend all assemblies, which have difficulties of any kind which seriously threaten to cause division in their midst, to seek the help of the Presbytery or the officers of the District Councils, where such exist, for advice before the division occurs.

Seventh: That, wherein any brother be used of God to establish an assembly in a new field, he be recognized as the logical overseer or pastor of that flock, and that he be encouraged to remain with the same assembly and feed it and care for it until the Lord shall raise up a pastor to take this responsibility and thus relieve him that he may press on to new fields; and if he shall find it needful to go before this is accomplished, let him confer with the nearest Presbyter, or the officers of the District Council, where such exist, before leaving. Thus we may avoid disaster that has come to many of the young assemblies that have been left without pastoral care.

### **Nominations and Elections (1925)**

Moved and carried that the recommendation of the General Presbytery in session in May, 1924, concerning nominations and elections be ratified, viz.: That we adopt the secret ballot in the nomination and election of candidates for executive offices. It was further resolved that all names presented be balloted upon until a candidate has a majority of votes, provided that if no majority is reached by the first three ballots, that the three candidates having the highest number of votes be nominees to be further voted upon, until one of them shall have received a majority.

Moved and carried to refuse to accept any withdrawals during the balloting of candidates, but that all names presented shall be balloted upon as above.

On motion it was agreed that the General Presbyters and Executive Presbyters should be voted upon one at a time, and each nomination should require a two-thirds majority to insure election.

### **Resolutions on Incorporation**

The Resolution Committee made the following report:

Whereas, It is necessary to become an incorporated body in order legally to transact business in the United States and Foreign Lands, we recommend the following resolution:

Resolved, That the General Council now assembled hereby authorizes the Executive Presbytery to incorporate the General Council of the Assemblies of God.

The above, after discussion, was, on motion, adopted unanimously.

In accordance with these instructions the General Council was incorporated according to the laws of the State of Arkansas, on October 30, 1914, with headquarters at Hot Springs, Ark., and according to the laws of the State of Missouri, on Nov. 1, 1916, with headquarters at St. Louis, Mo., and the incorporation was amended Oct. 6, 1919, with headquarters at Springfield, Mo.

### **District Councils**

The Resolution Committee recommended to the GENERAL COUNCIL that, whereas, it is impractical for all the Local Assemblies of God in the United States, and Foreign Fields to meet in the GENERAL COUNCIL, and whereas, it would be impossible for the GENERAL COUNCIL to transact the business of the Local Assemblies of God in the various sections of the United States and the Foreign Fields, we recommend that the Local Assemblies, in the various fields, establish District or State Councils, and that the Executive Presbytery be authorized to appoint Elders or Evangelists to assist the Local Assemblies of God in the recognition and establishing of the District or State Coun-



cils, that everything may be in harmony in the District Councils with the Constitution of the GENERAL COUNCIL.

### **Concerning District Councils**

Whereas, There has been some misunderstandings and complications arising out of the attempt to run a small district council within territory covered by a larger one, therefore be it

Resolved, That the General Council hereby expresses its disapproval of attempting to create and maintain a smaller district council within a portion of any field covered by a larger and more important district council. It disapproves of a district within a district. However, large districts covering several states may be divided whenever the forces in one of these states are large enough to maintain an effective council of their own and when these workers in any state are agreed the time for such move has come, and when this can be done peaceably and without impairing the effectiveness of the former district.

Resolved, That whenever a new district council in the future is to be formed and to be recognized as such by the General Council, due notice beforehand shall be given by those so contemplating to the General Council Office and to the officers of other adjacent districts whose territory or usefulness may be affected by the forming of the new district council. The new move should first have the approval of the General Office, and then be duly announced in the Evangel as to time and place where the forces intend to meet to carry out such purpose.

The two above resolutions were adopted.

### **Report on Changing Council Meetings**

Your Committee appointed at the last session of the General Council to consider the advisability of changing the frequency of the meetings makes the following recommendations:

1. That the General Council meet biennially (once in two years) instead of annually as heretofore.
2. That all Ministers or Assemblies affiliated with the Assemblies of God, with headquarters at Springfield,

Mo., be invited to affiliate themselves with the District Council with which they can the most conveniently be affiliated, and that in the future all recommendations for credentials come through the District Councils to the General Council Office.

3. That the District Councils be encouraged to make their annual meetings great and profitable gatherings to all the Pentecostal people of the entire District; and, with this end in view, we suggest that the officary of the General Council, or others qualified to help, be invited to attend such meetings for the purpose of keeping alive a proper relationship between the General Council and the District Councils and to advise in matters pertaining to our common interests.

4. That the officers of the General Council, including the General Presbytery, be elected at each biennial session of the General Council to hold office for a term of two years.

### **Church Offices and Officers**

The subject of the recognition of the different offices of the Church, which was referred back to the Resolution Committee, was revised and adopted as follows:

We, the Resolution Committee, recognizing that in the Word of God there are set certain offices, which represent the various activities of the body of Christ, recommend that the GENERAL COUNCIL declare itself in accord with the Word of God on this question, and stand ready to accept and endorse any and all of these various offices as they may appear or develop among us, and so far as they may now be present, we do stand ready to do so by suitable letters of commendation; and as a matter of convenience in their recognition, that we adopt the Scriptural terms of Elder, Pastor, Evangelist, Minister, Exhorter, and Deacon.

### **Rights and Offices of Women**

The Resolution Committee recommended to the GENERAL COUNCIL that whereas the hand of God is mightily upon many women to proclaim and publish the "good tidings of great joy" in a wonderful way, that the GENERAL COUNCIL of the ASSEMBLIES

OF GOD submit the following Scriptures for consideration:

1. In Christ, that is, in the matter of salvation, the lines of sex are blotted out (Gal. 3:28).

2. Women are commanded to be in subjection and not to usurp authority over the men in the churches (1 Tim. 2:11-15).

3. They are called to prophesy and preach the gospel (Acts 2:17). "He that prophesieth speaketh unto men to edification, to exhortation and to comfort" (1 Cor. 14:3; Ps. 68:11, R. V.).

4. To be helpers in the gospel (Rom. 16:3).

Therefore be it, Resolved, That this Council recommend to the ministry and Assemblies of God, that we recognize their God-given rights to be ordained, not as elders, but as evangelists, after being duly approved, according to the Scriptures; and that they serve as assistant pastors, missionaries, or as evangelists.

#### **Women Given the Voting Privilege**

Whereas, There is a strong sentiment among us in favor of granting our women a larger share of responsibility and privilege in our work, be it

Resolved, That all restrictions upon the privileges of women on the General Council floor be removed from the Minutes and records of the Council, and that they be given equal privileges with the brethren in voting upon all questions at the Council meetings, as well as in speaking. Carried.

#### **Violations of Ministerial Courtesy**

RESOLVED, That all discourteous conduct is disapproved and that all ministers are advised against interfering with others who may have charge of an assembly, whether it be by going in upon the work without consent of the one in charge or by such correspondence with the members of the assembly as will affect the influence of the leader. All correspondence which concerns the whole assembly, such as visiting that field, holding meetings, etc., should be addressed to the one in charge, not to private members. When there is no pastor, letters concerning the work should be addressed to the deacons or elders of the Assembly.



Any minister who so offends should be subjected to a Scriptural treatment as an offender, and it is recommended that it be given him by the local authorities, or the District Council, or if there be none, by the Executive Presbytery of the General Council. Such matters will seriously affect the granting of annual Fellowship Certificates and may be the basis of their recall.

### **Removal from General Council Fellowship (1925)**

Whereas, Occasions sometimes arise which make it necessary to deal with ministers who are affiliated with us and whose ministry may have ceased to be effective, and who for some reason may seem to have reached a place where in the judgment of the brethren the tie of Council fellowship should be dissolved, be it

Resolved, That both the officary of the District Council and the Executive Presbytery of the General Council be recognized as having the right of initiative in this matter, it being understood that in case the officary of a District Council shall recommend that Council fellowship be withdrawn from a minister, or his name dropped from the roll of Council ministers, the action shall be regarded as final, unless said minister shall avail himself of the right of appeal, in which case the matter shall be referred for ratification to the Executive Presbytery of the General Council, a three-fourths vote of said Executive Presbytery being required to adopt the recommendation of the officary of the District Council.

Be it further Resolved, That in case the Executive Presbytery shall exercise the right of initiative and shall find the accused guilty, the decision shall be referred to the officary of the District Council.

In case of an appeal from the decision of either the District officary or the Executive Presbytery of the General Council, the accused shall have the right of trial before a jury of five disinterested and impartial ministers, who shall be chosen by the joint officary of the General Council and District Council, and whose decision shall be final. It shall be under-

stood that the accused, in case of trial by jury, shall have the right of challenging five jurors.

Any minister who shall have been dealt with and whose name shall have been dropped, and who shall have availed himself of the right of appeal, shall be regarded as a temporarily suspended minister, pending the time of the hearing of said appeal and final settlement.

### **Standing Credential Committee**

Resolved, That the Chairman, Assistant Chairman and Secretary of the Executive Presbytery constitute a Credential Committee, and that the Council hereby authorizes them to bring out a form of credential certificate in keeping with the constitution and fundamental principles of the Council, and to issue annual certificates of fellowship to all ordained ministers in good standing; and further, on account of the expenditure incurred, and for the upkeep of the general office, applicants for credentials are requested to send in an offering of one dollar with their application for ordination certificate, and that each year thereafter, an annual offering of fifty cents be asked for to cover the cost of the fellowship certificate.

### **Duties of Credential Committee**

Resolved, That the Credential Committee shall issue credentials to qualified ministers in accordance with recommendations set forth in the Combined Minutes.

Resolved, further, That in the case of serious unscriptural teaching, of ministerial discourtesy, or other conduct unbecoming to a minister of the gospel, that those concerned refer these matters to the District Council or General Presbyter in the district where such minister may be located; and where these evils can not be corrected by this means, that these matters be referred to the Credential Committee, which shall deal with the same in a Scriptural way; and if it is found necessary, the Chairmen shall, with the agreement of the rest of the Committee, call for the credentials of such offender; but such accused person shall be later granted a fair and impartial trial, if desired.

## **Expiration of Fellowship Certificates**

Resolved, Inasmuch as all fellowship certificates expire on the 31st day of August of each year, that, hereafter, all who shall have failed to renew their fellowship certificates on or before November the 15th, or who shall have failed to indicate their purpose to do so, shall be considered as delinquents whose names shall not appear on the new ministerial list to be mailed to the clergy bureaus.

## **Prerequisites to Ordinations**

On motion, the following resolutions on the question of ordinations were adopted:

1. Resolved, That the General Council recommend that all candidates for ordination be first proved as licentiates, and only such as stand true and prove efficient, be ordained to the full ministry by any District Council.

2. Resolved, That we recommend no persons be ordained as missionaries. Persons *qualified* for the full ministry, whether called to the home work or the foreign field, should be ordained to the ministry. Those not qualified for the ministry should not be ordained, even though endorsed for the foreign field as workers.

## **Examinations and Time for Ordinations**

The following resolutions were adopted:

1. Resolved, That this Council advises all district councils to have published a regular set time and place once or more each year at which, as a rule, ordinations shall be performed in said districts.

2. Resolved, That each district is advised to have a committee of three or more which, with a General Presbyter, shall carefully examine into the candidate's character, life, soundness of doctrine, Christian experience, ministerial ability and previous success; and that these should be found satisfactory before the district council proceed with the ordination.

3. Resolved, That in states and territories where there are no district councils, the candidate for ordination or for credentials shall associate himself with the nearest or most convenient district council and then take the matter up with that district.



# A STATEMENT OF FUNDAMENTAL TRUTHS APPROVED BY THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD,

October 2 to 7, 1916

According to our Constitution we have the right to approve of all Scriptural truth. The Bible is our all-sufficient rule for faith and practice. Hence this Statement of Fundamental Truths is not intended as a creed for the Church, nor as a basis of fellowship among Christians, but only as a basis of unity for the ministry alone (i. e., that we all speak the same thing. 1 Cor. 1:10; Acts 2:42). The human phraseology employed in such statement is not inspired nor contended for, but the truth set forth in such phraseology is held to be essential to a full Gospel ministry. No claim is made that it contains all truth in the Bible, only that it covers our present needs as to these fundamental matters.

## I. THE SCRIPTURES INSPIRED.

The Bible is the inspired Word of God, a revelation from God to man, the infallible rule of faith and conduct, and is superior to conscience and reason, but not contrary to reason (2 Tim. 3:15, 16; 1 Pet. 2:2).

## 2. THE ONE TRUE GOD.

The one true God has revealed Himself as the eternally self-existent, self-revealed "I AM;" and has further revealed Himself as embodying the principles of relationship and association, i. e., as Father, Son and Holy Ghost (Deut. 6:4; Mark 12:29; Isa. 43:10, 11; Matt. 28:19).

## 3. MAN, HIS FALL AND REDEMPTION.

Man was created good and upright; for God said, "Let us make man in Our image and in Our likeness." But man, by voluntary transgression, fell, and his only hope of redemption is in Jesus Christ the Son of God (Gen. 1:26-31; 3:1-7; Rom. 5:12-21).

## 4. THE SALVATION OF MAN.

### (a) *Conditions to Salvation.*

The grace of God that brings salvation to all men has appeared through the preaching of repentance toward God and faith toward the Lord Jesus Christ; whereupon man is saved by the washing of regeneration and renewing of the Holy Ghost, and, having

been justified by grace through faith, he becomes an heir of God according to the hope of eternal life (Titus 2:11; Rom. 10:13-15; Luke 24:47; Titus 3:5-7).

(b) *The Evidences of Salvation.*

The *inward* evidence, to the believer of his salvation, is the direct witness of the Spirit (Rom. 8:16). The *outward* evidence to all men is a life of righteousness and true holiness (Luke 1:73-75; Titus 2:12-14); the fruit of the Spirit (Gal. 5:22); and brotherly love (John 13:35; Heb. 13:1; 1 John 3:14).

5. BAPTISM IN WATER.

The ordinance of Baptism by a burial with Christ should be observed as commanded in the Scriptures, by all who have really repented and in their hearts have truly believed on Christ as Saviour and Lord. In so doing, they have the body washed in pure water as an outward symbol of cleansing while their heart has already been sprinkled with the blood of Christ as an inner cleansing. Thus they declare to the world that they have died with Jesus and that they have also been raised with Him to walk in newness of life (Matt. 28:19; Acts 10:47, 48; Rom. 6:4; Acts 20:21; Heb. 10:22).

6. THE LORD'S SUPPER.

The Lord's Supper, consisting of the elements, bread and the fruit of the vine, is the symbol expressing our sharing the divine nature of our Lord Jesus Christ (2 Pet. 1:4); a memorial of His suffering and death (1 Cor. 11:26); and a prophecy of His second coming (1 Cor. 11:26); and is enjoined on all believers "until He comes."

7. THE PROMISE OF THE FATHER.

All believers are entitled to, and should ardently expect, and earnestly seek the promise of the Father, the baptism in the Holy Ghost and fire, according to the command of our Lord Jesus Christ. This was the normal experience of all in the early Christian Church. With it comes the enduement of power for life and service, the bestowment of the gifts and their uses in the work of

the ministry (Luke 24:49; Acts 1:4; 1:8; 1 Cor. 12:1-31).

#### 8. THE FULL CONSUMMATION OF THE BAPTISM IN THE HOLY GHOST.

The full consummation of the baptism of believers in the Holy Ghost is indicated by the initial physical sign of speaking with other tongues as the Spirit of God gives them utterance (Acts 2:4). This wonderful experience is distinct from and subsequent to the experience of the new birth (Acts 10:44-46; 11:14-16; 15:7-9). The speaking in tongues in this instance is the same in essence as the gift of tongues (1 Cor. 12:4-10, 28), but different in purpose and use.

#### 9. ENTIRE SANCTIFICATION THE GOAL FOR ALL BELIEVERS.

The Scriptures teach a life of holiness without which no man shall see the Lord. By the power of the Holy Ghost we are able to obey the command, "Be ye holy, for I am holy." Entire sanctification is the will of God for all believers, and should be earnestly pursued by walking in obedience to God's Word (Heb. 12:14; 1 Pet. 1:15, 16; 1 Thess. 5:23, 24; 1 John 2:6).

#### 10. THE CHURCH A LIVING ORGANISM.

The Church is a living organism; a living body; yea the body of Christ; a habitation of God through the Spirit, with divine appointments for the fulfillment of her great commission. Every true believer and every true local assembly are integral parts of the General Assembly and Church of the First-born, written in heaven (Eph. 1:22, 23; 2:22; Heb. 12:23).

#### 11. THE MINISTRY AND EVANGELISM.

A divinely called and a Scripturally ordained ministry is the command of the Lord for the evangelization of the world and the chief concern of the Church (Mark 16:15-20; Eph. 4:11-13).

#### 12. DIVINE HEALING.

Deliverance from sickness is provided for in the atonement, and is the privilege of all believers (Isa. 53:4, 5; Matt. 8:16, 17).



### 13. THE BLESSED HOPE.

The Resurrection of those who have fallen asleep in Christ, the rapture of believers which are alive and remain, and the translation of the true church, this is the blessed hope set before all believers (1 Thess. 4: 16, 17; Rom. 8: 23; Titus 2: 13).

### 14. THE IMMINENT COMING AND MILLENNIAL REIGN OF JESUS.

The premillennial and imminent coming of the Lord to gather His people unto Himself, and to judge the world in righteousness while reigning on the earth for a thousand years is the expectation of the true Church of Christ.

### 15. THE LAKE OF FIRE.

The devil and his angels, the beast and false prophet, and whosoever is not found written in the Book of Life, the fearful and unbelieving, and abominable, and murderers and whoremongers, and sorcerers, and idolators and all liars shall be consigned to everlasting punishment in the lake which burneth with fire and brimstone, which is the second death (Rev. 19: 20; Rev. 20: 10-15).

### 16. THE NEW HEAVENS AND NEW EARTH.

We look for new heavens and a new earth wherein dwelleth righteousness (2 Pet. 3: 13; Rev. 21 and 22).

## ADDENDA:

### THE ESSENTIALS AS TO THE GODHEAD.

(Being an explanation of Sec. 2 above.)

#### (a) *Terms Explained.*

The terms "Trinity" and "Persons," as related to the Godhead, while not found in the Scriptures, yet are words in harmony with Scripture, whereby we may convey to others our immediate understanding of the doctrine of Christ respecting the Being of God, as distinguished from "gods many and lords many." We, therefore, may speak with propriety of the Lord our God, who is One Lord, as a trinity or as one Being of three persons, and still be absolutely Scriptural. (Examples: Matt. 2: 6; 8: 16, 17; Acts 15: 15-18.)

#### (b) *Distinction and Relationship in the Godhead.*

Christ taught a distinction of Persons in the God-

head which He expressed in specific terms of relationship, as Father, Son and Holy Ghost, and that this distinction and relationship, as to its existence, is an eternal fact, but as to its mode it is *inscrutable* and *incomprehensible*, because *unexplained*. (That is, it is not explained as to *how* there can be three persons in the Godhead.) (Luke 1:35; 1 Cor. 1:24; Matt. 11:25-27; 28:19; 2 Cor. 13:14; 1 John 1:3, 4.)

(c) *Unity of the One Being of Father, Son and Holy Ghost.*

Accordingly, therefore, there is *that* in the Father which constitutes Him *the Father* and not the Son; there is *that* in the Son which constitutes Him *the Son* and not the Father; and there is *that* in the Holy Ghost which constitutes Him *the Holy Ghost* and not either the Father or the Son. Wherefore the Father is the Begetter, the Son is the Begotten; and the Holy Ghost is the one proceeding from the Father and the Son. Therefore, because these three eternally *distinct* and *related* Persons in the Godhead are in a state of *unity* and one in essence, there is but one Lord God Almighty and His name one (John 1:8; 15:26; 17:11, 21; Zech. 14:9).

(d) *Identity and Co-operation in the Godhead.*

The Father, the Son and the Holy Ghost are never *identical* as to *Person*; nor *confused* as to *relation*; nor *divided* in respect of the Godhead; nor *opposed* as to *co-operation*. The Son is *in* the Father and the Father is *in* the Son as to relationship. The Son is *with* the Father and the Father is *with* the Son, as to fellowship. The Father is not *from* the Son, but the Son is *from* the Father, as to authority. The Holy Ghost is *from* the Father and the Son proceeding, as to nature, relationship, co-operation and authority. Hence, neither Person in the Godhead either exists or works separately or independently of the others (John 5:17-30).

(e) *The Title, Lord Jesus Christ.*

The appellation "Lord Jesus Christ" is a proper

name. It is never applied, in the New Testament, either to the Father or to the Holy Ghost. It therefore belongs exclusively to the *Son of God* (Rom. 1:1-3, 7; 2 John 3).

- (f) *The Lord Jesus Christ, God with us.*

The Lord Jesus Christ, as to His divine and eternal nature, is the proper and only Begotten of the Father; but as to His human nature, He is the proper Son of Man. He is, therefore, acknowledged to be both God and man; who, because He is God and man, is "Immanuel," God with us (Matt. 1:23; 1 John 4:2, 10, 14; Rev. 1:13, 14-17).

- (g) *The Title, Son of God.*

Since the name "Immanuel" embraces both God and man in the one Person, our Lord Jesus Christ, it follows that the title, Son of God, describes His proper Deity, and the title, Son of Man, His proper humanity. Therefore, the title, Son of God, belongs to the *order of eternity*, and the title, Son of Man, to the *order of time* (Matt. 1:21, 23; 2 John 3; 1 John 3:8; Heb. 7:3; 1:1-13).

- (h) *Transgression of the Doctrine of Christ.*

Wherefore, it is a transgression of the Doctrine of Christ to say that Jesus Christ derived the title, Son of God, solely from the fact of the incarnation, or because of His relation to the economy of redemption. Therefore, to deny that the Father is a real and eternal Father, and that the Son is a real and eternal Son is a denial of the distinction and relationship in the Being of God; a denial of the Father and the Son; and a *displacement* of the truth that Jesus Christ is come in the flesh (2 John 9; John 1:1, 2, 14, 18, 29, 49; 8:57, 58; 1 John 2:22, 23; 4:1-5; Heb. 12:3, 4).

- (i) *Exaltation of Jesus Christ as Lord.*

The Son of God, our Lord Jesus Christ, having by Himself purged our sins, sat down on the right hand of the Majesty on high; angels and principalities and powers having been made subject unto Him, and, having been made both Lord and Christ, He sent the Holy Ghost that we, in the name of



Jesus, might bow our knees and confess that Jesus Christ is Lord to the glory of God the Father until the end, when the Son shall become subject to the Father that God may be all in all (Heb. 1:3; 1 Pet. 3:22; Acts 2:32-36; Rom. 14:11; 1 Cor. 15:24-28).

(j) *Equal Honor to the Father and the Son.*

Wherefore, since the Father has delivered all judgment unto the Son, it is not only the *express duty* of all things in heaven and in earth to bow the knee, but it is an *unspeakable joy* in the Holy Ghost to ascribe unto the Son all the attributes of Deity, and to give Him all the honor and the glory contained in all the names and titles of the Godhead (except those which express relationship. See paragraphs b, c and d), and thus honor the Son even as we honor the Father (John 5:22, 23; 1 Pet. 1:8; Rev. 5:6-14; Phil. 2:8, 9; Rev. 7:9, 10; 4:8-11).

---

### Unity in the Ministry

Inasmuch as unity among ministers is dependent upon their speaking the same thing on all fundamental matters (1 Cor. 1:10), the Credential Committee is hereby instructed to ask each applicant of the ministry for Credentials, or for a Certificate of Fellowship whether he recognizes and accepts the truth in the Statement of Fundamentals to the extent that he will endeavor, with all lowliness and meekness and loving forbearance, to keep the unity of the Spirit in the bond of peace till we all come in the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ (Eph. 4:2, 3, 13).

This Committee is hereby instructed to issue credentials to those who agree, and to refuse to those who seriously disagree; and that in the case of minor disagreements, the committee is instructed to use its own discretion in the matter; and that in the case of violations of the agreement and the causing of trouble and division, they are instructed to deal with the case as directed in

the item pertaining to Violations of Ministerial Courtesy.

### **Our Distinctive Testimony**

The resolution was adopted as follows:

Resolved, That this Council considers it a serious disagreement with the Fundamentals for any minister among us to teach contrary to our distinctive testimony that the baptism of the Holy Spirit is regularly accompanied by the initial physical sign of speaking in other tongues as the Spirit of God gives the utterance, and that we consider it inconsistent and unscriptural for any minister to hold credentials with us who thus attacks as error our distinctive testimony.

### **Resolution on Baptismal Formula**

Resolved, That since the words in Matt. 28:19 and the words in Acts 2:38 were both inspired of God, we hereby disapprove of contending for the one to the exclusion of or as against the other, because confusion and a party spirit are sure to follow such unscriptural conduct. This Council therefore recommends that all our preachers include in their formula used in connection with the act of baptism the words used by Jesus in Matt. 28:19.

### **Marriage and Divorce**

The Resolution Committee recommended to the GENERAL COUNCIL that:

First. Whereas, There are now among Christian people those who became entangled in their marriage relations in their former lives of sin, and who do not now see how these matters can be adjusted, therefore we recommend that these cases be left in the hands of the Lord, and that they walk in the light as God lets it shine on their souls.

Second. Whereas, Low standards on marriage and divorce are very hurtful to individuals, to the family, and to the cause of Christ, therefore be it recommended that in the future we discourage divorce by all lawful means and teaching, and that we shall positively disapprove in the future of Christians getting divorce for

any cause except for fornication or adultery (Matt. 19:9); and that we recommend the remaining single of all divorced Christians, and that they pray God so to keep them in purity and peace. (See 1 Cor. 7.)

Third. Whereas, Divorced and remarried persons in the ministry usually cause stumbling, reproach and division, whatever may have been the cause of divorce, therefore we advise and recommend our ministers and Assemblies in the future not to ordain to the full gospel ministry those who have remarried, and are now living in the state of matrimony, while former companions are living (Ezek. 44:22).

Fourth. And as a means of making the above more effective, we further advise our Pentecostal ministry not to perform a marriage ceremony between any believer and a divorced person whose former companion is still living. We also especially warn all our people that unions made in the future and in the face of this warning between any of our ministers and such divorced persons will effect the standing of both the minister who performs the ceremony, unless he is innocently deceived into doing the same, and also that of the minister entering into such union, whether man or woman, and no matter on which side the divorce lies (1921).

### **Support of the General Council Office**

The following resolution was adopted:

Whereas, The work of the General Council in its definite program of development of the spirit of co-operation and fellowship in home and foreign fields will incur considerable expense during the coming year, including financial support of the Chairman, Assistant Chairman, and Secretary, and such other help as may be needed, in maintaining headquarters, stationery, postage, traveling expenses, etc.;

Resolved, That every minister in the fellowship be requested to contribute from his tithes or as an offering, or through his influence, the sum of one dollar per month. And further, looking towards the increased efficiency of the General Council throughout the entire field, all who can contribute more, personally or through their assemblies, than the suggested amount, are hereby strongly

urged to do so. If practicable, let each assembly take one offering each year for the upkeep of the General Council office and traveling expenses.

### **Auditing the Accounts**

On motion, the following resolution was adopted:

Resolved, That we hereby direct the Executive Presbytery to have the books of the General Council office, Missionary Department and Publishing House audited each year.

### **Paying Tithes**

Resolved, That this Council hereby urges all its ministers to teach their people the duty of paying tithes to God, and to turn them over regularly as much as is needed to the support of their local ministry; and any surplus, or where there is no local ministry, to their respective headquarters, for the spread of the Gospel throughout the world. According to the Scriptures, tithes are to go to the support of the active ministry, and not to charity and other purposes. All ministers should practice what they preach.

### **Regarding Secret Societies**

Resolved, That all ministers affiliated with us refrain from identifying themselves with any of the secret orders which we recognize as essentially of the world, worldly, and we advise any who may have identified themselves with such orders to sever their connection therewith.

### **Publishing Interests**

Resolved, That the Gospel Publishing House, with all its interests, including all papers and periodicals, be and is hereby committed permanently into the hands of the Executive Presbytery to supervise and direct, also to appoint such help as is needed personally to conduct the same.

### **Circulation of Good Literature**

On motion, the following resolution was adopted:

Resolved, In view of the great need of spreading the Gospel to all men everywhere, that Pentecostal preachers and laymen distribute freely in all depots, jails and public places our Pentecostal Evangel and other good Pente-



costal literature; and that the various assemblies be recommended to subscribe for the Evangel to go into the Public Libraries in their cities, and all other places where permitted.

### **Resolution on Publications**

Whereas, It is deemed advisable to safeguard the Publishing House from matter for publication that is undesirable,

Resolved, That all matter offered for publication, and to bear the imprint of the Gospel Publishing House, which contains doctrines that in the judgment of the staff at Headquarters are seriously questionable, shall be submitted to a Committee on Publications, composed of five men, three of whom shall be outside the staff at Headquarters, for investigation and approval, such committee to be elected by the Council, and such books to receive the approval of at least a majority of this Committee before being published with the Gospel Publishing House imprint on them.

The above resolution was adopted, and the following committee was elected: J. W. Welch, Wm. M. Faux, D. W. Kerr, Joseph Tunmore and J. N. Gortner.

### **The New Policy of the Foreign Missions Dept. (1925)**

The following policy was adopted as a substitute for our missionary policy as outlined in the Combined Minutes of 1923 from the middle of page 26 to the end of page 36.

Whereas, The General Council has put itself on record as being ready to follow New Testament methods in the conduct of its work in the foreign lands, therefore be it

Resolved, That we hereby establish a distinct Missionary Department under the supervision of the Missionary Secretary and recommend that all missionary interests of the General Council be co-ordinated into it. Further, recognizing the many expenses entailed in the maintenance of a forward missionary policy, that this Council recommends that all assemblies and individuals, when sending in missionary offerings, send additional contributions for the support of the Missionary Department.

Resolved, That this Council exert all its powers to promote the evangelization of heathen lands according to New Testament methods.

First: In the proper testing of those who claim to be called to foreign work (Rev. 2:2; Acts 13:1-4).

- A. As to a personal experience of full New Testament salvation.
- B. As to a definite call to foreign work.
- C. As to physical, mental and spiritual fitness for work.
- D. As to Christian standing, being first endorsed by their local assembly.

Second: Every assembly ought to have a definite part in sending and maintaining one or more missionaries of its own, or sharing the burden of one or more missionaries with one or more other assemblies.

Third: Missionaries receiving the Baptism on the field ought to be brought in touch with and supported by the assemblies having no missionaries of their own.

Fourth: Missionaries while home on furlough should be considered as on vacation and be supported and supervised in the same manner as while on the field.

Fifth: That wherever there are enough missionaries, District Councils should be formed who will supervise their local affairs.

Sixth: Where numbers are not sufficient to warrant forming a District Council, then the missionary shall be amenable directly to the Foreign Missions Department until they do become strong enough in number to form a District Council.

Whereas, Our blessed Master said to His disciples, "Go ye into all the world, and preach the Gospel to every creature," we believe it is alike our privilege and our duty to assist in every practical effort to get the full Pentecostal message to the uttermost ends of the earth, therefore be it

Resolved, That this Council heartily recommends that every local Pentecostal assembly take up a monthly offering for our Pentecostal missionaries

who are faithfully laboring to preach the Gospel "to every creature."

Resolved, That the undesignated funds sent to the Foreign Missions Department of the General Council should be sent to those who have received the endorsement of the General Council and who are in harmony with the fundamental truths for which this Council stands. All funds assigned to particular persons will be forwarded by the Foreign Missions Department exactly as directed.

Whereas, In the providence of God there have sprung up spontaneously in this movement throughout the country, Pentecostal centers, and

Whereas, These places have gathered about them a constituency by the publication of periodicals for the dissemination of Pentecostal truths, and

Whereas, In consequence moneys for missionary purposes are being sent to these various centers and distributed upon the mission field, therefore be it

Resolved, That the Foreign Missions Department be instructed to bring about a more perfect co-operation among these centers, in the matter of distribution of missionary funds, and the sending out of missionaries, with a view to greater efficiency in each of these various centers.

Resolved, That all missionaries going out to the foreign field who desire the endorsement of this General Council and its aid, by having it divide among them the undesignated funds coming into our hands, shall report to the Foreign Missions Department and receive its approval before leaving this country. Otherwise, this Council will assume no responsibility for their going out or for their support after arrival upon the field. That in all cases where there are representative Pentecostal missionaries on the field who do not seek such approval, we will nevertheless gladly forward to them all funds coming into our hands designated for them.

Resolved, That the Foreign Missions Department renew the fellowship certificates of all foreign missionaries on the field in good standing on or before the first of the year without cost to the missionaries.

The Pauline example will be followed so far as possible, by seeking out neglected regions where the gospel has not yet been preached, lest we build upon another's foundation (Romans 15:20).

It shall be our purpose to seek to establish self-supporting, self-propagating, and self-governing indigenous churches.

A proper distribution of funds may be made according to an understanding had between the missionaries on the field and the Foreign Missions Department.

It is recommended that the missionaries send a report of moneys received and submit a budget of expenses to the Foreign Missions Department.

It shall not be incumbent upon the Foreign Missions Department to send of its undesignated funds to missionaries who do not furnish such a report.

Appeals for special offerings to meet special needs shall be made in agreement with the District Councils on the field and the Foreign Missions Department.

Prospective missionaries will be expected to exercise faith in God to provide their outfit and fare to the field so far as practicable.

Resolved, That we heartily recommend that should any prospective missionary be prevented from going forward to the field, for any reason, that such funds which were intended for outfit, fare, and expenses while on the field shall be either returned to the parties from whom received, if desired by them, or made available for other missionaries or missionary purposes.

No offerings for the support of native workers shall be sent direct to the natives, but to the missionaries under whose supervision they work.

### **Co-operation of Missionary Work Defined**

1. Resolved, That all missionaries who desire the endorsement of the General Council should make application for an appointment certificate provided they already hold credentials from the General Council; and that those not holding credentials may make



application for the same and for appointment certificate.

2. Resolved, That all missionaries making application for credentials and appointment certificates shall be expected to subscribe to the statement of Fundamental Truths approved by the General Council of the Assemblies of God.

3. Resolved, That each missionary be requested to file with the Foreign Missions Department a full statement regarding their work, e. g., concerning their families and accommodations, period of service, language qualifications, nature of work engaged in, prospects of the field, present number of recognized adherents, etc., etc.

4. Resolved, That it be urged upon the Foreign Missions Department the necessity of insisting upon two full years of language study, if necessary, before taking up the full active work, and that courses of study with examinations be arranged for by an advisory committee on each field. No missionary should fail to get the language during the first term out on the field. If he does fail, his fitness for a second term may be questioned.

5. Resolved, That we recommend that the Pentecostal missionaries in the several distinct foreign districts come together in co-operation according to our liberal constitution and establish District Councils in co-operative relationship with the General Council of the Assemblies of God. We recommend that officers be elected who are in full sympathy with the Fundamental Truths for which this Council stands, and who have the endorsement of the Council.

6. Resolved, That in the matter of providing funds for missionary homes, stations, schools, and such like, adequate and proper safeguards, such as complying with the laws of the respective countries for the legal holding of property, and such as establishing and maintaining a proper relationship between these missionary projects and the General Council, be made first before the Council funds are made available for same.

7. Resolved, That all missionary property should be held by the General Council wherever legally possible.

8. Resolved, That all missionaries planning to return to the home field co-operate with the Foreign Missions Department where there is not a District Council on the field, in making arrangements for a supply to take charge of their work or station, and that they co-operate with the Foreign Missions Department to secure and forward funds for the maintenance of such work or station during their absence.

Resolved, That in fields where there are already Pentecostal missionaries on stations, that consultation be had with the brethren on the field and the Missionary Department, and a satisfactory place be agreed upon before opening up new stations in those regions.

Amendment: That a copy of the policy be submitted to all General Council missionaries at home and abroad to look over and make suggestions concerning same.

Resolved, That a missionary committee of three be appointed apart from the Executive Presbytery to whom the Missionary Secretary can refer all matters of vital importance for counsel and decision, they with the Missionary Secretary to comprise the Foreign Missions Department.

### **Missionary Schools**

Resolved, That the General Council hereby directs the Missionary Committee to take under advisement the establishment of schools for the education of duly accredited Native Workers, in the various fields where practicable, also schools for the education of the young children of missionaries where possible.

### **Mexican Missions**

Whereas, There is already a blessed and prosperous work among the Mexicans along the Mexican border, and

Whereas, There are quite a number of approved missionaries who are giving their entire time to this work, therefore be it

Resolved, That a special fund be created by appeal

from the Missionary Department through the Pentecostal papers for the support of this Mexican work, and that a proportionate share of the undesignated funds be available for this work, at the discretion of the Missionary Committee..

### **Missionary Rest Home**

On motion, the following resolution was adopted:

Resolved, That this Council hereby approves and ratifies the action of the General Presbytery in providing for, through the officers of the General Council, a Missionary Rest Home in Chicago, and that we provide for the election of a Committee of Management.

### **Resolution on Home Missions**

Whereas, There exists among us a strong conviction that a beginning should be made, looking toward the speedy evangelization of the neglected places in the Home Field, therefore be it

Resolved, That all well organized districts capable of a Home Missionary program shall be left to the District Councils to care for, and that all other territory be considered as Home Missionary fields.

Section 1. We suggest to the well organized districts that some definite plan for raising and distributing Home Missionary funds be devised at the next regular meeting to which all associated ministers can agree after a careful survey of the field.

(a) That a fund be established and placed in the hands of the District Presbytery to be disbursed according to the plan agreed upon.

(b) That the plan of the District Council in its Home Missionary work include an agreement with all missionaries employed as to the place of effort, the time of its beginning, the amount of funds to cover expenses for the first month, and succeeding months; also as to the reports from the missionaries to the District Presbytery with a view to maintaining proper co-operation and oversight in the work.

Sec. 2. In the matter of providing for the Home Missionary Field, that there be established in the Gen-

eral Council a Home Missionary feature under the supervision of the existing Missionary Committee.

(a) That a fund be created through appeals in the Evangel and plans agreed upon for offerings to be made by the assemblies and individuals; funds to be distributed as authorized by the Missionary Committee on the same 100 per cent basis as is done in the case of Foreign Missions.

Sec. 3. Further, the Missionary Committee is instructed to perfect a plan for providing workers for the Home Missionary field and for the disbursement of funds for the Home Missionary Department, upon an understanding previously made with workers similar to those suggested to the District Councils.

Sec. 4. In districts now or at any time to be organized where the District Council is not sufficiently strong to meet the needs of an unoccupied territory, such District Council may officially appeal for help to the Home Missionary Department for assistance, providing such assistance be rendered according to funds in hand and at the discretion of the Missionary Committee, who should consider all appeals upon their merits. Such Home Missionary work done in organized fields should be done in accord with the plans of the Home Missionary Department, the District Council co-operating. Applications for help from such territories are to be made by District Council officers and not by individuals.

Sec. 5. In the matter of taking offerings, the Committee suggests, where no better plan is provided, that there be set out three baskets. The first to receive offerings for Foreign Missions, with the understanding that special emphasis is to be given this item of the offering. The second basket to be for Home Missions. The third basket to represent the expense fund of the whole Missionary Department, both Home and Foreign. Simply give God a chance by placing all three interests regularly before the saints, and leave it to the Lord as to what they shall put in each basket.

The Committee worked out the following plan:



### **Home Missionary Plan**

First. Work will be undertaken only as funds are available.

Second. The choice of fields for operation shall be made by the Missionary Committee after all available information is in hand.

Third. Only such persons as have been approved and appointed by the Missionary Committee will be listed as home missionary evangelists.

Fourth. All Home Missionary work shall be under the supervision of the Missionary Committee.

Fifth. Missionary evangelists will be expected to remain on the field until the work is established and its care provided for.

Sixth. Each community where work is undertaken will be encouraged to help support the workers from the beginning and the new assembly will be expected to assume its entire self-support as soon as able to do so.

Seventh. As soon as possible each community evangelized will be given an opportunity to make an offering to replace the fund expended on its evangelization for the purpose of evangelizing another new field.

### **Recognition of Our Relationship in the Body**

Whereas, The Scriptures teach that we are all in one Spirit baptized into one body; and whereas, because of this fact, we are already organically, co-operatively, and sympathetically related one to another; and whereas, there seems to be everywhere a prevailing lack in the understanding of these principles, therefore be it

Resolved, That the General Council hereby recommends to all our ministers that they give definite and repeated instructions on the necessity of *recognizing* these already existing principles as set forth in Paul's teaching in 1 Cor. 12: 12-27, etc., and urge them to a faithful adherence to the same in all their relations one to another in the body of Christ.

### **Fellowship and Co-operation**

Resolved, That we again declare our Christian fellowship with every true child of God, and that we stand ready also to co-operate with all Christians who stand for our Fundamental teachings.

Resolved, further, That the officers of this Council and of our Publishing House are hereby directed to heartily co-operate with all such who will also really co-operate with us.

### **Co-operative Relationships**

Resolved, That this General Council recommend to the Executive Presbytery that they proceed to formulate suggestive plans to be presented to the officers of the various District Councils and General Presbyters, where District Councils do not exist, clearly defining co-operative relationships, that there may be a uniformity in the matter of setting churches in order, and an understanding of the relationships that exist in the local assembly, its officers and pastor, and between the local assemblies and District and General Councils.

### **Safeguarding the Assemblies**

On motion, the following resolution presented by the Eastern District Council was adopted:

Whereas, It is known that many unreliable and unsafe teachers and preachers go about seeking entrance into assemblies without any recommendation, be it

Resolved, That all pastors, workers and leaders of Assemblies make proper investigation regarding such not known to them, and that the platform be denied strangers until proper recommendations be forthcoming.

Futhermore, be it resolved, That the advice and counsel of the District Presbyterian be sought in such cases, and in all matters of importance when at all possible, and that pastors and presbyters notify each other, reciprocally, as to such persons when any unreliability becomes manifest.

### **Recommendation to Local Assemblies**

Resolved, That the General Council recommends to all local assemblies that they seek to establish a well-ordered assembly and to maintain Bible order and Bible government. They should be set in order and proper records kept of all business meetings.

### **A Co-operative Evangelism**

As a Council, we hereby express our gratitude to God for His great blessing upon the movement in the

past. We are grateful to Him for the results attending this forward movement, and we commit ourselves and the movement to Him for the greatest evangelism that the world has ever seen. We pledge our hearty co-operation, prayers and help to this end.

### **Field Work**

Resolved, That this Council shall encourage a series of Bible and Missionary Conferences in various centers throughout the country, and that the Chairman shall be Office Superintendent of this field work. He shall have the right to appeal to any presbyter, evangelist, teacher, missionary or other minister to aid in the conduct of such work.

### **Bible Schools (1925)**

The Committee on Bible Schools presented the following resolutions, which by motion were adopted:

Whereas, The General Council already owns and controls the Central Bible Institute at Springfield, Missouri, and

Whereas, there are other schools being operated by the brethren of our Council fellowship in other districts, therefore be it

Resolved, That the General Council hereby express its hearty sympathy with every effort to provide practical training for prospective ministers and missionaries where the standards of teaching and discipline maintained in the schools are satisfactory.

Resolved, That the General Council shall encourage the further development of the Central Bible Institute, together with such other schools as may meet the standards as herein set forth:

First: The Central Bible Institute, together with such other schools as may become affiliated with the General Council, shall co-operate with a view of standardization of courses of study and methods along practical lines.

Second: That the devotional and spiritual life of these schools shall be based on loyalty to the Word of God, and a personal knowledge of God, through Jesus Christ, by the power of the Holy Ghost.

Third: The doctrinal teachings shall conform to

those set forth in the fundamental teachings of the General Council of the Assemblies of God.

Fourth: The examinations, reports, certificates, and diplomas shall be given on an equality with the Central Bible Institute as set forth on pages 22 and 23 of their catalogue for 1925-1926 under that heading in matters of credits and conditions.

Fifth: The General Council shall have a representative who shall be a member of the directorate or ex-officio member of the board of trustees, or management of schools in this fellowship.

Finally, all schools which meet the above mentioned conditions and which are received into the co-operative fellowship of the General Council shall be considered as being equal in the matter of their graduates.

### **Bible Study and Convention Lectures**

On motion, the matter of Bible Schools was referred to the General Presbytery, who brought forth the following resolution, which was adopted:

Whereas, There is a great famine in the land for the Word of God and a great need that the people of God should be fed with knowledge and understanding of the Scripture by those who are placed over them in the Lord; therefore,

Resolved, That we encourage our people as a whole, and our young people especially, to attend faithfully to a diligent search of the Scriptures, and if possible to attend some properly and Scripturally accredited Bible Training School; and further,

Resolved, That in all our public gatherings, camp meetings, and conventions, we give to the Bible its due place, and that provision be made by those in charge, for the fullest exercise of the gift of teaching by those who are specially called and qualified thereto; and be it further

Resolved, That we encourage "Ten-Day Bible Conferences," or "Itinerary Bible Schools," to be held in different sections of a given district, in which due attention shall be given to evangelistic work for the unsaved, and solid Scriptural teaching for the saints.



## **Sunday Schools**

A resolution also passed recommending to the Executive Presbytery that they do their best to make provision for, and stimulate interest in Sunday Schools for the children and young people in our midst.

### **Against Setting a Time for the Lord's Return**

Resolved, That it is unwise to teach that the Lord will come at some specified time, thereby setting a date for His appearing; and also, that it is unwise to give out from the platform, or publish visions of numbers and dates fixing the time of the second coming of the Lord.

### **Heresies Disapproved (1925)**

On motion the following resolution was adopted:

Resolved, That this Council hereby disapproves of the Seventh-Day teaching, of the extreme so-called Eternal Security teaching, of a teaching known as the Fourth Blessing of Perfection, of the so-called Social and Marital Purity teaching, and of the Pridgeon doctrine, and that hereafter those holding and agitating such teaching thereby causing confusion and division among God's people shall be dealt with according to Titus 3:10.

### **Meats**

The Conference Committee recommended that whereas the pressing of the question of eating, or not eating meats, is causing divisions in some of the Assemblies, that the General Council recommend their disapproval of such extreme positions on this question which cause these divisions, and that we recognize the right of each individual conscience in this matter, according to Col. 2:14-17.

### **Resolution Concerning the Attitude of the General Council of the Assemblies of God toward Any Military Service which Involves the Actual Participation in the Destruction of Human Life**

While recognizing Human Government as of Divine ordination and affirming our unswerving loyalty to the Government of the United States, nevertheless we are

constrained to define our position with reference to the taking of human life.

Whereas, In the Constitutional Resolution adopted at the Hot Springs General Council, April 1-10, 1914, we plainly declare the Holy Inspired Scriptures to be the all-sufficient rule of faith and practice, and

Whereas, The Scriptures deal plainly with the obligations and relations of humanity, setting forth the principles of "Peace on earth, good will toward men" (Luke 2: 14); and,

Whereas, We as followers of the Lord Jesus Christ, the Prince of Peace, believe in implicit obedience to the Divine commands and precepts which instruct us to "Follow peace with all men" (Heb. 12: 14), "Thou shalt not kill" (Ex. 20: 13), "Resist not evil" (Matt. 5: 39), "Love your enemies" (Matt. 5: 44), etc., and

Whereas, These and other scriptures have always been accepted and interpreted by our churches as prohibiting Christians from shedding blood or taking human life;

Therefore, We, as a body of Christians, while purposing to fulfill all the obligations of loyal citizenship, are nevertheless constrained to declare we can not conscientiously participate in war and armed resistance which involves the actual destruction of human life, since this is contrary to our view of the clear teachings of the inspired Word of God, which is the sole basis of our faith.

### **Expression of Loyalty to the Government.**

Resolved, That the General Council hereby declares its unswerving loyalty to our Government and to its Chief Executive, and that we hereby restate our fixed purpose to assist in every way morally possible, consistent with our faith.

## **MINUTES OF THE GENERAL COUNCIL**

**Held at Eureka Springs, Ark., Sept. 17 to 24, 1925**

The Eleventh session of the General Council of the Assemblies of God convened at 9:00 a. m., Sept. 17, 1925, under a large tent in Eureka Springs, Ark.,

with a spirited song service, after which Elder J. W. Welch and Elder D. W. Kerr led the assembly to the throne in prayer.

### **Thursday Morning**

At 10:00 a. m. Chairman J. W. Welch introduced the following speakers who in a few words welcomed the General Council to Eureka Springs, viz.:

Dr. A. C. Ellis, President of the Eureka Springs Commercial Club.

B. J. Rosewater, Secretary of the Eureka Springs Commercial Club.

Rev. R. S. Hayden, Pastor Methodist Church.

Rev. W. C. Wood, Pastor Baptist Church.

Rev. G. A. Hudson, Pastor Presbyterian Church.

Chairman J. W. Welch then responded with a few appropriate words of appreciation in behalf of the General Council.

Chairman J. W. Welch made the opening address to the Council, re-affirming the General Council principles.

The Council adjourned at 12 m. to meet at 2 p. m.

### **Thursday Afternoon**

Afternoon meeting opened at 2:15 with prayer by Elder S. A. Jamieson.

### **Lay Delegates**

Moved and carried that we abide by the interpretation given by the Chairman, that we only recognize one lay delegate from each assembly, to be effective this session only.

### **Roster Committee**

The Roster Committee then made a partial report which was accepted.

### **Rules and Order Committee**

The Rules and Order Committee presented the following resolutions, which upon motion were adopted:

Resolved, That we reaffirm our position concerning adherence to parliamentary rules in all matters coming before this body; and that we recommend that

the Chairman insist, in the interest of the conservation of time, that such adherence be conformed to, provided it be understood that the Spirit of God be given the right of way at all times, and it is to be understood that this resolution shall not be interpreted so as to interfere with the carrying out of the will of the majority.

Resolved, That all resolutions be signed by their authors, and that the author of each resolution be given the first right to speak thereon, and that he be given all the time he may need to interpret the resolution and to advocate its passage.

Brother McDowell then took charge of the meeting with a short talk on Fellowship, followed by a testimony and fellowship meeting.

The Council adjourned at 5:00 p. m. to meet again at 8:30 the following morning for devotional service, and 9:30 a. m. for business meeting.

### **Thursday Evening**

Meeting opened with a song service.

Miss Blanche Appleby spoke of the work at Lo Pau, South China.

Brother Jonathan E. Perkins, of Tulsa, Oklahoma, brought us a rousing message on "The Meaning of Pentecost."

### **Friday Morning**

Devotional service at 8:30 conducted by Elder H. B. Laws.

The business meeting opened at 9:30 with prayer by Chairman Welch.

Minutes of Thursday meetings read and approved.

J. R. Evans, General Secretary, then read the minutes of the Executive Presbytery meeting for the past two years. Moved and carried that said minutes be approved as read.

The Secretary then read the report by the Executive Presbytery of the General Council activities during the period between Sept. 1, 1923, and Sept. 1, 1925, covering all departments of the work. Moved and carried that the report be accepted as read.

### GENERAL COUNCIL FELLOWSHIP

---

Since our last General Council meeting two years ago we are glad to report a very healthy growth in all the General Council activities.

In our General Council fellowship, in 1923 we had 1085 ministers in the homeland holding General Council credentials; today we have 1155 ministers having Council endorsement.

Inasmuch as we have dropped from our ministerial list through lapses and for other reasons 178 names, and also report that twelve of our number have been called home to be with Jesus, making a total of 190, deducting these from the number reported two years ago, shows that we have received into our fellowship 260 new ministers, or a net gain of 70.

We are glad to report a very healthy financial condition as well as a growth in membership, some of our brethren have responded very heartily to the recommendation of the General Council Presbytery to send in a regular amount for the upkeep of the office. The following report is the summary:

## REPORT OF CENTRAL BIBLE INSTITUTE

---

We are grateful to the Lord to be able to report His seal on the Central Bible Institute. This has been evident in the supply of means to erect the building as it now stands and in the manifestation of His presence in classroom and dormitory. Numerically the school has shown healthy growth, so that already its clothes are too small. The first year (in the Assembly basement) the enrollment was sixty-five; the second year, in the same location, seventy-five; and the last year in the new building one hundred and fifteen. For 1925-1926 the dormitories are filled (104 students) with a dozen day students enrolled and as many are on the waiting list unable to enter.

The chapel unit is greatly needed to increase our classroom space and to provide an auditorium for graduation exercises and a place where services and a Sunday school might be held in this part of Springfield. The erection of a number of small cottages, similar to the one already on the grounds, to house our married students, would open the dormitories to more single young people. Pray for the supply of these needs.

## **REPORT OF MISSIONARY DEPARTMENT FOR PERIOD COVERING TWO YEARS**

### **MISSIONARY SECRETARY'S REPORT, 1925**

It becomes my pleasant duty to submit to you the bi-annual report of the Foreign Missions Department. It is the purpose of the Missionary Department to render the best possible service in the interests of the world-kingdom of Christ. To this end the situation from past and present correspondence, together with interviews and conferences with missionaries, and with reports from the field, was carefully studied. We recognize the important responsibility committed to our trust. The Foreign Missions Department considers itself an organized agency of the church, created for the specific purpose of carrying on in an intelligent and efficient way the church's missionary work. The purpose of foreign missionary work is two-fold. First, it is organized to extend the knowledge of Christ throughout the earth by utilizing the resources of the church with the view of establishing self-supporting native churches in each field. Second, to promote an interest in foreign missions by approved methods in the home churches.

In addition to this the Missionary Secretary was sent abroad to make a survey of some of the mission fields, observe the actual existing conditions, facts, and other items of interest in order to get a better understanding and a closer spirit of co-operation on the part of all concerned. The fields visited were India, Egypt, Palestine and Syria. As a result of this visitation some of our convictions on missionary work have been deepened and others radically changed.

We realized as never before the dead weight against which our missionaries were working, the dire opposition on the part of those who are bitter antagonists to Christianity, the vileness of these native religions, and sin abounding everywhere. The people are largely in bondage to fear. With this thought in view, how necessary that all of our missionaries should be deeply spiritual, established in the Word and rooted in Christ.

It was also learned that the necessary qualifications for effective work is hearty co-operation on the part of all concerned. There is too much of independent missionary activity. This minimizes efficiency, and sometimes causes difficulties.

From careful observations made in the light of the world-kingdom of Christ, it appears that a solid, united, concentrated effort on the part of all Pentecostal missionaries would facilitate the work and result in far greater effectiveness. The crying need of India is the ability on the part of the Christians and missionaries to demonstrate the superiority of Christianity as a religion over and above that of Hinduism, Mohammedanism or any other.

Two years ago we had on our list two hundred and twenty-two missionaries; today we have two hundred and thirty-five. Of this number thirty-seven are home on furlough. These missionaries are working in the following fields: China 72, India 63, Japan 13, Africa 47, South America 10, Porto Rico 5, Mexican Border work 10, Palestine 3, Poland 3, West Indies 4, Alaska 2, Syria 1, Hawaii 1, Persia 1. Of those on furlough 7 are hoping to return to the field this fall.

These men and women have done excellent work. They have left their native home and country for the foreign land, depriving themselves of many of the comforts and necessities of life, subjecting themselves more or less to the dangers of disease and to inconveniences for the sake of carrying the Gospel of Jesus to these benighted, superstitious, fear-bound and godless peoples. This is a noble task to engage in and these men and women deserve our highest commendation.

In India we have 63 missionaries, 65 native workers, 28 Bible women, 24 teachers, 2 Council schools and 4 day schools. Of the 2 Council schools, one is a boys' school with 72 boys, and the other a girls' school with 90 girls. There are 16 stations and 14 out-stations. The work in India is mostly evangelistic. Schools occupy a secondary part, then orphanages, leper and zenana work. At Bara Banki is a children's nursery, where little outcast and deserted children are taken in and brought up to know the Lord. The children are kept there until the age of seven, when they are sent to one of the schools. At two stations a very interesting work is also being done among the unfortunate lepers.

In China the situation is rather critical, particularly in South China, where the work is closed for the present as far as the missionaries are concerned. This is due largely to an unstable government, concessions to foreign governments and student unrest which usually follows when young men are educated without inculcating the inherent principles and life of Christ in the heart. The work in North China feels somewhat the effects of the student reaction but goes on unhindered. The difficulty in West China has been amicably adjusted with the result that God has greatly blessed them in their work. In China there are 64 missionaries. Other statistics on account of the present uprising cannot be given.

The work in Africa is being established upon a more efficient basis. The situation in the French Sudan with 4 missionaries, and in the Congo Belge with 6 missionaries, has become adjusted and our missionaries there are fast winning the approbation and confidence of the people and officials. The enlargement of the work in South Africa with 6 missionaries, is handicapped for the lack of funds and recruits. In Liberia some of the tribes are earnestly pleading for missionaries to teach them the Gospel of Christ.

In Egypt we have 7 missionaries and 17 native preachers who are begging for a superintendent to oversee the work. There are 16 stations. Some of



these are in a flourishing condition and one is self-supporting.

The work in Palestine is most encouraging but needs two married couples to assist and give it the proper standing in the eyes of the people. There are 5 missionaries, 2<sup>e</sup> stations. Regular jail work and much distribution of literature is engaged in.

In Syria we have one lone lady missionary among three or four million people. The people are hungry for the Gospel. Here a married couple is sadly needed to give prestige and standing among the hungry and needy people. This work is most commendable. One missionary, 1 native worker, 23 members, 8 teachers, 1 school.

In Japan our missionaries are gradually working their way into the hearts of the people regardless of the difficulties. In this land are 13 missionaries assisted by 4 native workers, 5 stations and 6 out-stations with a membership of 71. There are also 11 teachers employed.

Our missionary work in Porto Rico, notwithstanding the many discouraging features, is in a prosperous condition. It is conducted by 7 missionaries and 5 native workers. According to the latest report received they have 25 organized churches having a membership of about 8,000 and 6 other places for regular worship. They have 25 Sunday schools with 50 teachers. The natives contribute about \$2,000 for Gospel work during the year.

On the Mexican Border and in Mexico a vigorous work has been accomplished by 8 faithful missionaries. These are ably assisted by 57 native workers who preach in the various stations.

Our work in South America is very meager at present. We have 3 missionaries in Argentina and 3 in Peru who are doing well under the circumstances. Venezuela has 1 missionary.

In the British West Indies we have 4 missionaries, 12 native workers and 76 members.

In Hawaii there is 1 missionary and in Alaska 2 missionaries, with a membership of 12 in the latter.

In Poland 5 missionaries, 2 native workers and a

membership of 180. This is a most needy field with many opportunities for the future.

In Ceylon are 4 missionaries and 2 stations with many possibilities for an excellent work.

In Freetown, West Africa, there are 2 missionaries with a membership of 50 believers. Prospects are good.

The assemblies have been represented on the foreign field by a deeply consecrated and loyal body of missionaries. If our faith was tried so was theirs. It was difficult often for them to see why America in her abundance was not more enthusiastic about giving the Gospel to all the world. Sometimes they were living on the very border of poverty and suffering. They could not understand when they pled hopelessly and in vain for our help, why our hearts were not wrung like theirs and why we could be so happy and content with so much distress and pain.

Several changes have occurred in the Missionary Personnel, mostly through ill health and death.

(See list Sunday memorial service.)

Arrangements ought to be made to finance the present current work and maintain our quota of missionaries at its fullest efficiency. The church needs to provide some means for securing necessary funds for equipment and buildings. We need to give careful consideration to our unoccupied responsibility. Promising opportunities and fruitful possibilities lie before us. A selection of choice, qualified, God-called men with a burning passion for souls and a mentality for leadership should be prayed forth.

Missionary work at present is more imperative than ever. Present-day evil influences are vitally affecting the moral status of the Orient, thus intensifying the danger. Evidences of vices from alleged Christian nations exist, so much so, that one wonders whether the closer contacts of the East and the West are further to debauch the East. They surely will unless they are overcome by a more vigorous propagation of Christianity.

The old civilizations of the Orient are crumbling under forces good and bad which are pouring into

their lands. Their native religions are not adequate to meet the changing conditions. Moral restraints have weakened and the whole structure is in danger of collapsing.

What is the duty of the Christian church at such a time as this? Is it not stated in the words of our Lord, "This Gospel of the Kingdom shall be preached in all the world," "Go ye, therefore, and disciple all nations"? Christianity is the only adequate force. The Christian church is committed to that program. There is no other hope, "For there is none other Name given under heaven among men whereby we must be saved." The only hope for the world lies in the acceptance and practice of the Gospel of the Son of God. The missionary enterprise stands for that, for uttermost allegiance to Christ as "King of kings and Lord of lords."

"Is this a time, O Church of Christ, to sound retreat?  
To arm with weapons cheap and blunt  
The men and women who have borne the brunt  
Of truth's fierce strife, and nobly held their ground?  
Is this the time to halt, when all around  
Horizons lift, new destinies confront?  
No, rather strengthen stakes, and lengthen cords,  
Enlarge thy plans and gifts, O thou elect;  
And to Thy Kingdom come for such a time.  
The earth with all its fulness is the Lord's.  
Great things attempt for Him, and great things expect,  
Whose love imperial is, whose power sublime."

## MISSIONARY TREASURER'S REPORT, 1925

---

The records of the Foreign Missions Treasurer have yielded some encouraging and most interesting information. Great strides have been made in missionary giving during the past two years which have ended with Aug. 31, 1925. The past year, especially, has been a year of increasing confidence on the part of the Pentecostal constituency in our missionary program, and this confidence has shown itself in a large increase in missionary giving.

Note the following comparative statement:

For two years ending August 31, 1921.....\$198,765.95

For two years ending August 31, 1923.... 247,367.81

For two years ending August 31, 1925.... 321,422.69

The 1924-5 report shows an increase of \$74,054.88 over the previous two years.

It also shows an increase of \$122,656.74 over the two years ending August 31, 1921.

The larger part of this increase came in 1925, for the offerings received during 1924 amounted to \$144,-319.47 and the offerings received during 1925 amounted to \$177,103.22.

It may be interesting to note that since the establishment of the Foreign Missions Department as a distinct feature of the Council Executive, in 1919, the Foreign Missions Treasurer has handled a total of \$767,556.45 (over three-quarter million dollars). This has been handled so successfully that there has been no loss to the missionaries with the exception of two checks issued by a New York bank on Africa, which bank went into the hands of a receiver before the checks were cashed. These checks could not be collected. With this exception, all this money has traveled over mountain and plain, over land and sea, in ten thousand checks and drafts, reaching the remotest parts of the earth in safety and bringing comfort and cheer to hundreds of our missionaries and their native helpers.

---

### **Distribution of Funds**

The following report shows the distribution of funds for the two years ending August 31, 1925. The report for 1924 is not so complete as that for 1925, inasmuch as no record was kept of the details of the distribution. Since the first of September, 1924, however, a more detailed account has been kept. These records yield the following information.

### The Yearly Distribution

In the early days since the Foreign Missions Department was established, the chief burden seemed to be the personal allowances of the missionaries, with little thought for the extra responsibilities of mission station expense, native workers, fares to and from the field, buildings, etc. Since we have decided to look upon the field as a whole and to recognize the need of supporting missions as well as the missionaries, much has been accomplished in the way of a more general distribution of funds. The personal allowances of the missionaries still takes the major portion of missionary funds. Missionaries on furlough received the next largest portion. Our records for 1925 show the following distribution:

In addition to the above, \$4,000.00\* was sent to China for relief purposes on account of the recent political upheaval. Part of this fund has been used and the balance is being held in trust for any impending emergency. There was raised \$1,109.93 for the

work in the Island of Montserrat following the typhoon which destroyed the homes of our people there and our Pentecostal mission. Some funds were sent to India to help in the relief of the flood sufferers and the balance was used for special designations and designated offerings for missionaries who are not working under the General Council.

During the past year the people have expressed their confidence in the Foreign Missions Department by sending in offerings amounting to \$10,239.85, leaving it to the judgment of the Missionary Department as to where the money should be placed. This money was not sent in for Foreign Missions primarily, but was sent in to the Treasurer with the stipulation that it could be used in any place, in the home or foreign field, where there was a need. The deputation to India, covering ten months cost \$1770.14 and this was paid out of this special fund. The amount remaining was turned in to the Foreign Missions fund and sent to the missionaries. None of this money was used in the homeland, with the exception of \$300.00.

---

### **Expense of Foreign Missions Department**

Offerings for Foreign Missions have been sent to the field dollar for dollar and nothing has been deducted from these offerings to cover the home office expense. With the addition of a foreign secretary to the home office force in 1923, the necessity of moving his family to Springfield, and the need for caring for his needs and those of his family, the Office Expense Fund has been put to a most severe test. While the expense of conducting the office nearly doubled with the addition of the foreign secretary to the office force, the offerings for the expense of the department did not increase proportionately. During the year ending August 31, 1924, the offerings toward the office expense fund amounted to \$5574.84. The office expense for that same year amounted to \$8152.09, making a difference of \$2577.25. We were only enabled to get through the year by practicing the utmost economy. The deficit was made up through the sale of missionary literature and offering barrels, the collection of

interest from the bank on our daily deposits and a small grant from the special fund above referred to. This grant was authorized by the Executive Presbytery and amounted to \$300.00. Without this grant the Foreign Missions Department would have had to close down during the year 1924. The year closed with no balance on hand.

The year of 1925 was a better year, both in offerings for Foreign Missions and also for the office expense fund. The total offerings for the office expense fund amounted to \$6295.69. The year closed with a small balance of \$90.79. During this year, the expenses of the office were kept down to the minimum. While two office assistants were needed in the office during the absence of the secretary, yet the work was carried on by the treasurer with one office assistant. There is still vast room for improvement in our plan for financing the Foreign Missions Department.

Much more might be placed in this report to prove of interest to all our Council brethren, but before closing we would refer to the marked results from the Missionary Convention Program under Brother Kelley, which program was instituted in the District Councils covering the states of Florida, Alabama and Mississippi. In addition to meeting the expense of the conventions, these states more than doubled their missionary offerings.

The records in the Missionary Treasurer's office are complete, so that a statement showing the total offerings received from each state, each year can be furnished upon application. Most states show a steady increase in missionary giving from year to year.

This report does not show the amount forwarded to the field or given to visiting missionaries by local assemblies, but only shows the actual amount which passed through the hands of the Foreign Missions Treasurer. All assemblies giving their money direct instead of sending through the hands of the Treasurer, and yet who have co-operated by making a report of the amount sent out, have found that full credit has been given in the weekly report of missionary offerings published in the Evangel. The total offerings given direct and reported to the Treasurer are \$15,289.38 during 1924 and \$9,418.71 during 1925.

The meeting was opened by prayer by Elder Wm. Morwood.

The secretary then read a pamphlet entitled "The Interpretation of the Constitutional Agreements and

Essential Resolutions," recommended by the Executive Presbytery, 1925.

Moved and carried that these resolutions be given due consideration and be made the first order of business on Saturday morning.

There being no further old business, the business meeting was adjourned at 4:00 p. m.

Evangelist J. S. McConnell then gave a splendid message, his subject being "Love."

### **Friday Evening**

Meeting opened with a song service.

Mrs. Jennie Bendicksen spoke of the work in the Congo Belge, Africa.

Elder J. Narver Gortner, of Los Angeles, Calif., brought us a splendid message on "Prayer."

### **Saturday Morning**

Devotional meeting at 8:30 conducted by Elder W. E. Moody, followed by prayer for the sick and afflicted.

The business meeting opened at 9:00 with prayer by Elder T. K. Leonard.

A special musical number was rendered by the Hartford Music Company quartette.

Minutes of Friday meetings read and approved.

In answer to a call for representatives from different states and countries, it was found that 34 states and 9 countries were represented in the Council delegation.

Moved and carried that the following resolution be adopted:

Resolved: That no changes be made to the Constitutional Agreements unless the same is passed by a two-thirds majority.

Moved and carried that the speakers on the above Constitutional Agreements be limited to ten minutes each, and that all speakers come to the platform.

Moved and carried to have no more preliminary addresses.

Moved and carried that the Chairman call a meeting of the General Presbyters at the close of the after-

noon meeting to consider the appeal of Brother Fred Lohmann.

Moved and carried that the Constitutional Agreements be considered item by item.

Council adjourned at 12 m to meet at 2 p. m.

### **Saturday Afternoon**

Afternoon meeting opened at 2:00 with song, followed by prayer by Elder F. M. Boyd.

Moved and carried that the following resolution be adopted, viz.:

Recognizing ourselves primarily as a missionary body, and with our interests centered in that direction, be it

Resolved, That the evening services begin 15 minutes earlier, and the preliminaries be shortened so the missionaries may have from 30 to 40 minutes before the evangelistic service each evening.

A number of speakers availed themselves of speaking on the Constitutional Agreements until time for adjournment.

Council adjourned at 5:00 p. m.

### **Saturday Evening**

Meeting opened with a song service.

Miss Sara Coxe spoke of the work at Bihar, India.

Elder W. T. Gaston brought us a fine message on "Our Kingly and Priestly Office."

### **Sunday Morning**

The Sunday morning meeting opened with a good song service and a time of united prayer, after which Miss Olga Jean Aston in charge of the Baby Nursery at Bara Banki, U. P., India, explained her work and told many thrilling and inspiring stories of rescuing babies and raising them for the Lord. At the close of her address she produced a native costume that had been given her, in which she robed herself in the presence of the audience to the delight of all.

### **Memorial Service**

The memorial service in memory of our beloved workers who have gone on to be with Jesus, was in charge of Elders J. R. Evans and Wm. M. Faux.

Brother Evans reported that twelve of our be-



loved ministers have gone home to glory since the 1923 General Council meeting, viz:

He spoke of their devotion, suffering, patience and love for their work.

Now that these missionaries have rest from their labors and we have only the influence of their fragrant lives left with us, may we ever be inspired to truer missionary devotion in the future.

Elder D. W. Kerr then brought us a splendid message on "Missions." The Spirit of God was very blessedly present throughout the service.

Brother Kerr spoke of the reputation he has earned for being a "Crank on Missions." But this is no surprise for the church is a missionary body, there being now one missionary for every five preachers, 1155 preachers, and 235 missionaries.

### Sunday Afternoon

At the afternoon meeting, four ladies and two men sang "Wonderful Story of Love" in Hindi, repeating

the chorus in English, the great crowd joined in. In a similar way two women and three men sang in Spanish, "He's Coming Soon," and five women and three men sang a song in Chinese. It was most unusual and entertaining.

The interest aroused however, by Miss Blanche R. Appleby, of Lo Pau, Kwantung Province, South China, in delivering a message in Chinese, having the same interpreted by George M. Kelley, of Sainam, Kwantung, has perhaps not been exceeded in this series of meetings. To be preached to through an interpreter, by one speaking in Chinese in the regular way of preaching with an interpreter, was a novel and exciting experience. In this message, Miss Appleby presented to the General Council a rich and beautiful silk banner possibly two by nine feet, gorgeously decorated and resplendent with the words, "Other sheep I have," beautifully embroidered both in English and Chinese. It was the gift of the Chinese.

B. A. Schoeneich, of Matagalpa, Nicaragua, in a message expressed in well formed and luminous sentences, gave a graphic account and striking word picture of missionary difficulties and victories in Roman Catholic Latin America.

Elder Wm. M. Faux, Missionary Secretary, then spoke briefly of his trip to India, Palestine and Egypt, giving his impressions of the mission work in these countries.

### **Sunday Evening**

At night Mrs. Margaret Kelley, of Sainam, Kwangtung Province, South China, in a marvelous Spirit-filled address declared in many different connections and diverse forms of approach, that like Queen Esther, the Pentecostal church has come to the kingdom for just such a time as this. She declared it to be no time for retrenchment nor for watchful or even prayerful waiting but that the uncompromising cry of God to Moses is ringing again today, "Speak unto the people that they go forward." This message was followed by a collection which in cash and pledges amounted to the great sum of \$59,732.47. This was

later increased to \$72,855.28. The cash offering was \$514.28. This eleven-year-old church last year raised for missions \$177,000 in cash. A husky infant to be sure.

Elder Robert A. Brown, of New York City, then spoke with the greatest force against the sins that are destroying the world. He startled the crowd by declaring in dramatic pose that a man who does not pay his tithes will never get to Heaven. As the people paused, he added the words—"if he has the light." A man who has the light and will not walk in it, will get into darkness. The sermon was followed by a most effective altar call.

There were splendid meetings also in three of the churches of the city that had invited Pentecostal ministers. Brother S. A. Jamieson, of Chicago, preached in the morning at the Presbyterian church and D. H. McDowell preached in the evening. Brother T. K. Leonard, of Findlay, Ohio, preached in the Methodist church in the morning and Dr. Morse H. Markley, of Asbury Park, N. J., preached in the evening. Brother Leonard preached in the Baptist church in the evening service.

### **Monday Morning**

Devotional meeting at 8:30 in charge of Elder Fred Vogler, opened with a musical number by the Bostrom Brothers Trio.

Business meeting opened at 10:00 with prayer by Elder S. H. Frodsham.

Minutes of Saturday meetings read and approved.

The Resolution Committee presented the following resolution, which upon motion was adopted:

Resolved, That the recommendation embodied in the pamphlet, "Interpretation of the Constitutional Agreements and Essential Resolutions," be tabled indefinitely, and that the Council reaffirm its adherence to the agreements as shown in the Combined Minutes of the General Council of 1923.

Additional report of the Roster Committee. Moved and carried that the roster be closed.

Moved and carried to adopt Resolution on Nomi-

nations and Elections (see Combined Minutes, Pages eight and nine).

### **Election of Officers**

Moved and carried that we proceed with the election of officers. The following brethren were elected to the various offices of the Council.

Mr. A. G. Ingalls of the Eureka Springs Commercial Club submitted to the Council for consideration an invitation to establish a permanent meeting place for the General Council in Eureka Springs.

Moved and carried that we express to the Commercial Club our appreciation for this kind offer, and that it be referred to the General Presbytery for consideration. (We understand that the brethren of Arkansas and adjacent States have agreed to hold an Interstate Camp Meeting each year in Eureka Springs, and the Commercial Club will build the auditorium for them whether the Executive Presbytery accept their offer or not.)

Moved and carried that the office of Missionary Treasurer be abolished, and that we appoint a General Treasurer instead.

After two special selections by the Bostrom Brothers Trio it was moved to adjourn.

Adjourned at 5:00 p. m.

### **Monday Evening**

A missionary address by Brother J. R. Jamieson, of Barbadoes, West Indies, followed by a splendid message by Elder H. E. Bowley, of Dallas, Texas, on "The Holy Spirit and what He will do after He comes."



## **Tuesday Morning**

Devotional meeting at 8:30 in charge of Elder J. M. Goodson.

Business meeting opened at 9:30 with prayer by Elder Frank Gray.

Minutes of Monday meetings read and approved.

The Resolution Committee presented the following resolution, which upon motion was adopted.

"Whereas, At the meeting of the District Council Assemblies of God in Texas and New Mexico, held in Fort Worth, Texas, August 4th to 8th inclusive, 1925, it was unanimously voted to extend an invitation to the Texas Woman's Missionary Council to become a part of the organization working with it in the great missionary enterprises of the church as well as carrying forward our own work among the prisons, the sick, and the poor of our own land; therefore be it

Resolved, That we, the Texas Woman's Missionary Council, accept the invitation extended by the District Council and pledge our hearty co-operation and support."

The brethren entered into a profitable discussion on the principle of tithing, which was enjoyed by all tithers.

Moved and carried that a love offering be taken for the retiring Chairman, our beloved Brother Welch, in appreciation of his years of faithful service as an officer of the General Council, and that the Executive Presbytery be authorized to add to the amount received, from the Gospel Publishing House funds, whatever may be necessary to make a minimum amount of \$1,000.00, to be paid to Brother Welch.

Moved and carried to adjourn at 11:30 to have a photograph taken of the assembled throng.

Adjourned at 11:30 a. m.

## **Tuesday Afternoon**

The meeting opened at 2:00 with a special song by Elder C. A. McKinney, followed by prayer by Brother Gaston.

A petition was presented by Elder G. A. Chambers, Chairman of the Pentecostal Assemblies of Canada,

applying for a severance of organic relationship, but retaining the fraternal relationship and tie of fellowship with the General Council of the U. S. A.

Moved and carried to adopt the following resolution:

Whereas, The Canadian brethren have petitioned the General Council for discontinuance of the present organic relationship, and have asked that the fraternal relationship shall continue, be it

Resolved, That the General Council of the Assemblies of God in the U. S. A. accede to the request of the Pentecostal Assemblies of Canada, and

Whereas, The discontinuance of this organic relationship involves the ministerial relation and missionary interests of both bodies, be it further

Resolved, That a commission consisting of two members from each body be appointed to adjust such matters equitably.

### **General Treasurer**

The Resolution Committee presented the following resolution, which upon motion was adopted:

That owing to the marked growth of the financial interests and property holdings of the General Council that the General Council shall create the office of Treasurer and authorize the Executive Presbytery to select a man qualified for the place. He shall be custodian of all General Council funds, keep an accurate record of all receipts and disbursements, conduct the work of his office according to accepted business methods, and shall report from time to time as requested by the General Council or Executive Presbytery. He shall make such contracts as shall be agreed upon by the Executive Presbytery. He shall perform such other duties as are customary to his office as may be directed by the General Council or the Executive Presbytery.

Moved and carried that a love offering be taken for Brother J. R. Flower, retiring Missionary Treasurer, in appreciation for his faithful services, and that the Executive Presbytery be authorized to cancel a

debt of \$1,000.00 against Brother Flower at the Gospel Publishing House.

Moved and carried that the Chairman appoint a committee of five to nominate representative men for the office of General Presbyters, it being understood that all District Chairmen shall be General Presbyters.

The following brethren were appointed as a nominating committee: Fayette Romines, T. Arthur Lewis, J. S. McConnell, W. E. Moody, and J. C. Wilder.

Moved and carried to adjourn. Council adjourned at 5:00 p. m.

### **Tuesday Evening**

Brother Jonathan Nader, of Chicago, spoke in behalf of the Persian work, after which Elder Jacob Miller (better known as Uncle Jake), of Fort Smith, Ark., in his own delightful manner gave a splendid message on "The Blood of Jesus."

### **Wednesday Morning**

Devotional meeting opened at 8:30 in charge of Elder H. B. Laws.

Business meeting opened at 9:45 with prayer by Elder J. Narver Gortner.

Minutes of Tuesday meetings read and approved.

### **General Presbyters**

The Nominating Committee presented the names of 24 brethren to be voted upon for General Presbyters.

Moved and carried that these names be voted upon one at a time, and that a two-thirds majority be required for election.

The brethren whose names appear on Page 72 in the back of the book were duly elected as General Presbyters.

### **1925 Minutes**

Moved and carried that the editors of the 1925 minutes be authorized to leave out all matter made obsolete by resolutions passed at this session.

Moved and carried to adopt the following resolution:

Resolved, That there shall be elected six Executive

Presbyters who are resident at Springfield, Mo., and three non-resident, a total of nine; the Chairman, Assistant Chairman, Secretary and Missionary Secretary to serve for their term of office, and the others to serve for four years each, and it is recommended that they meet at least twice annually.

Moved and carried that the Chairman appoint a committee of three to present nominees for non-resident members of the Executive Presbytery. The following brethren were appointed: J. Narver Gortner, C. A. Lasater, and E. S. Williams.

Moved and carried to adjourn. Adjourned at 12 m.

### **Wednesday Afternoon**

Afternoon meeting opened with prayer by Elders W. H. Pope and S. A. Jamieson.

#### **New Executive Presbyters**

The Nominating Committee made their report and the following brethren were elected Executive Presbyters.

Resident: S. H. Frodsham. (Brother F. M. Boyd has two more years to serve.)

Non-resident: J. Narver Gortner, Ernest S. Williams, and S. A. Jamieson.

#### **Removal from General Council Fellowship**

Moved and carried that the resolution presented regarding removal from General Council fellowship be adopted. See Combined Minutes, page 13.

The Resolution Committee presented the following resolution, which upon motion was adopted:

Resolved, That a committee of five be appointed by the Chair who shall be authorized and instructed to go over our minutes and take therefrom the essential resolutions which have been passed in former years by the General Council, and that these resolutions, together with such further statements as may seem necessary and which are in harmony with our Council agreements be used to formulate a basis of our co-operative fellowship.

Be it further Resolved, That this compilation of General Council essential resolutions be completed within four months from the date of the closing of



the Eleventh General Council Session, and that it be referred to all the District Councils of the Assemblies of God for ratification or correction, and that it be placed again in the hands of the committee for final revision at least two months prior to the meeting of the Twelfth General Council of the Assemblies of God.

Be it further Resolved, That this amended and revised General Council basis of our co-operative fellowship be the first order of new business at the next session of the General Council, and that its acceptance or rejection be decided by a two-thirds majority vote.

### **Missionary Policy**

The missionary policy as found on page 26 in the Combined Minutes upon motion was adopted after quite a lengthy discussion by different ones on the floor of the Council.

### **Bible Schools**

The Bible School resolution as found on page 36 in the Combined Minutes upon motion was adopted by the Council.

### **Heresies Disapproved**

Upon motion the resolution found on page 38 in the Combined Minutes was adopted.

Moved and carried that all remaining necessary business be referred to the Executive Presbytery, and that they be authorized to properly care for same.

Moved and carried that the Executive Presbytery be authorized to edit, correct, and publish the Minutes of this Council session as soon as possible, and that a copy be sent to each minister of the Council.

Moved and carried that we extend to the officials and citizens of Eureka Springs by a standing vote our hearty appreciation for their untiring efforts in our behalf, and to Pastor E. J. Bruton and his congregation and official board our hearty thanks for their efforts in making things pleasant during our stay.

Moved and carried that we extend a vote of thanks to Mr. Duneway, reporter for the Eureka Springs and

other newspapers; for his kindness in reporting the meetings.

Moved and carried that the time and place for holding the next General Council meeting be arranged for by the Executive Presbytery. Moved and carried to adjourn. After prayer by Elder Robert A. Brown, the Eleventh General Council was adjourned at 5:10 p. m. and passed into history.

### **Wednesday Evening**

Brother Frank Nicodem brought the missionary message, and Elder T. K. Leonard, of Findlay, Ohio, gave a fine message on "Lord, teach us to pray." (May God grant it.)
